In accordance with O.C.G.A. 21-2-131(a)(1)(A-B), the governing authority of all counties in Georgia must establish and publish qualifying fees for upcoming elections.

Subparagraph B establishes the qualifying fee for a County Commissioner as 3% of the base salary established by local Act of the General Assembly exclusive of compensation supplements for training provided for in O.C.G.A. 36-5-27 and cost of living adjustments (COLAs) pursuant to O.C.G.A. 36-5-28.

On July 14, the Board of Elections called for a Special Called Election for Post 5 of the Fayette County Board of Commissioners in order to replace Vice Chair Pota Coston who passed away while in office.
