He thanked his friends and his office staff for their support. He stated that he looked forward to working with and hearing from the county staff. He concluded by thanking those who voted for him and stated that he was going to try to do all that he could to earn the citizen's votes. He stated that he looked forward to working with the Board.

Commissioner Oddo moved to close the nominations for Chairman. Commissioner Brown seconded. No discussion followed. The motion passed 5-0.

Commissioner Brown moved to elect Commissioner Eric Maxwell as Chairman. Commissioner Rousseau seconded. No discussion followed. The motion passed 3-2 with Commissioners Oddo and Ognio voting in opposition.

Commissioner Maxwell was named the Chairman of the Board of Commissioners for the year 2017 and he proceeded with the nominations for Vice-Chairman.

Commissioner Rousseau moved to elect Commissioner Oddo as Vice Chairman. The motion died for a lack of a second.

Commissioner Brown moved to elect Commissioner Ognio as Vice Chairman. Commissioner Oddo seconded. No discussion followed. The motion passed 5-0.

# 7. Approval of the December 8, 2016 Board of Commissioners Meeting Minutes.

8. The Chairman of the Board of Commissioners to appoint a position to the Board of Health.

Chairman Maxwell asked if anyone on the Board would like to serve on the Board of Health. Commissioner Brown suggested Commissioner Rousseau. Commissioner Rousseau agreed to serve on the Board of Health.

Vice Chairman Ognio moved to appoint Commissioner Rousseau to the Board of Health. Commissioner Brown seconded. No discussion. The motion passed 5-0.

9. Consideration of a recommendation from the Selection Committee, comprised of Commissioner Randy Ognio and Commissioner Steve Brown, to re-appoint John Culbreth to the Fayette County Planning Commission for a term beginning January 1, 2017 and expiring December 31, 2019.

Commissioner Brown acknowledged that Mr. Culbreth was in the audience and he stated that Mr. Culbreth was serving an unexpired term and he had done a wonderful job.

Commissioner Brown moved to re-appoint John Culbreth to the Fayette County Planning Commission for a term beginning January 1, 2017 and expiring December 31, 2019. Vice Chairman seconded. Discussion followed.

Vice Chairman stated that the County received applications from some great candidates, but that there were limited positions. He encouraged the applicants to continue to apply for other positions.

Commissioner Brown moved to re-appoint John Culbreth to the Fayette County Planning Commission for a term beginning January 1, 2017 and expiring December 31, 2019. Vice Chairman seconded. The motion passed 5-0.

10. Consideration of a recommendation from the Selection Committee, comprised of Commissioner Randy Ognio and Commissioner Steve Brown, to re-appoint Brian Haren to the Fayette County Planning Commission for a term beginning January 1, 2017 and expiring December 31, 2019.

Commissioner Brown acknowledged that Mr. Haren was in the audience and he stated that Mr. Haren had done a magnificent job on the Planning Commission and that he was working on the committee for the Comprehensive Plan as well.

Commissioner Brown moved to re-appoint Brian Haren to the Fayette County Planning Commission for a term beginning January 1, 2017 and expiring December 31, 2019. Vice Chairman Ognio seconded. Discussion followed.

Vice Chairman reiterated that there were some great applicants to apply, but that there were limited positions.

He continued that staff is monitoring the weather closely and that a press release for inclement weather would be distributed if needed. He concluded that each Commissioner received a copy of the SPLOST projects via CD on the dais.

Commissioner Rousseau asked Mr. Rapson to explain the SPLOST interactive map on the County's website.

Mr. Rapson explained that on the County's website there is an interactive map of all the projects within the county, both unincorporated Fayette County and the Municipalities. He stated that citizens can click on the map to see the locations of the projects. He encouraged citizens to reach out to the County and Municipalities if they have questions.

Commissioner Oddo congratulated Chairman Maxwell and Vice Chairman Ognio and stated that he would work closely with each one of them and the entire Board. He stated that Sam Wellborn, the representative for District 3 at Georgia Department of Transpiration, asked if he could come before the Board on a quarterly basis to discuss transportation projects. He stated that he informed Mr. Wellborn that he would be welcomed and that the County has a new Transportation Committee. Commissioner Oddo asked staff to get send Mr. Wellborn the Transportation Committee's meeting schedule.
