JOB SUMMARY: This position assists in the appraisal of residential property.

## **MAJOR DUTIES:**

o Assists in the compilation of the annual real property digest.

- o Measures new construction and additions to residential structures and draws field sketches.
- o Records characteristics of structures and takes photographs.
- o Performs annual revaluations of existing constructions.
- o Enters field sketches into computer sketch program and prints results.
- o Assembles field drawn sketches, building permits, and completed property record cards and photographs for Lead Appraiser for review.
- o Matches city and county building permits with the correct property record cards.
- Assists commercial property, personal property, and administrative personnel as needed.
- o Serves on the Disaster Assessment Team to identify storm damages structures and assess dollar amounts of damages.
- o Assists with mailing annual assessment notices.
- o Assists with customer inquiries; refers to appropriate personnel.
- o Performs other related duties as assigned.

## KNOWLEDGE REQUIRED BY THE POSITION:

- o Knowledge of framing, plumbing, and electrical construction practices.
- Knowledge of department operations.
- Skill in reading and interpreting aerial maps, blueprints, plats, building permits, property deeds, and surveys.
- o Skill in taking, editing, printing, and uploading digital photographs.

- o Skill in measuring and drawing new construction and additions to existing construction.
- o Skill in oral and written communication.

SUPERVISORY CONTROLS: The Residential Lead Appraiser assigns work in terms of somewhat general instructions. The supervisor spot-checks completed work for compliance with instructions and established procedures, accuracy, and the nature and propriety of the final results.

GUIDELINES: Guidelines include the Appraisal Manual. These guidelines are generally clear and specific, but may require some interpretation in application.

COMPLEXITY: The work consists of related duties in assisting in the appraisal of real property. Changes in residential construction designs contribute to the complexity of the position.

SCOPE AND EFFECT: The purpose of this position is to assist in the appraisal of residential property. Success in this position contributes to the accurate appraisal of residential property.

PERSONAL CONTACTS: Contacts are typically with members of the general public, other county employees, real estate agents, bank personnel, and representatives from other organizations.

PURPOSE OF CONTACTS: Contacts are typically to give or exchange information; resolve problems; and provide services.

PHYSICAL DEMANDS: The work is typically performed while sitting at a desk or table or while intermittently sitting, standing, or stooping. The employee occasionally lifts light objects and uses tools or equipment requiring a high degree of dexterity.

WORK ENVIRONMENT: The work is typically performed in an office and outdoors. The employee may be exposed to dust, dirt, grease, machinery with moving parts, and occasional cold or inclement weather.

SUPERVISORY AND MANAGEMENT RESPONSIBILITY: None.

SPECIAL CERTIFICATIONS AND LICENSES: Possession of a valid State of Georgia driver's license (Class C) and a satisfactory Motor Vehicle Record (MVR) in compliance with County Safety and Loss Control Guidelines. Completion of the State of Georgia Department of Transportation Defensive Driving Course and/or Emergency Vehicle Operation Certification within twelve (12) months of employment.
