6. Consideration of Petition No. A-552-05, Gin-Jer Investments, LLC, Owner, and Gerard P. Chandler, Agent, request a 17 foot Variance to reduce the fifty (50) foot landscape area along S.R. 54 West from a minimum of 50 feet to a minimum of 33 feet; request a seven (7) foot Variance to reduce the ten (10) foot landscape strip along all side property lines from a minimum of ten (10) feet to a minimum of three (3) feet; request a Variance to allow placement of all required parking in the front of the building/structure; and request an eighteen (18) foot Variance to reduce the 30 foot buffer from a minimum of thirty (30) feet to a minimum of twelve (12) feet to allow site plan approval of an existing structure for O-I uses. This property is located in Land Lot 70 of the 7th District, fronts on S.R. 54 West, and is zoned O-I.
