COMMUNICATION TOWERS CHECKLIST
FOR ADMINISTRATIVE APPLICATION SUBMITTAL

ALL OF THE FOLLOWING ITEMS ARE REQUIRED FOR APPLICATION SUBMITTAL FOR NEW COMMUNICATIONS TOWERS. ANY DEFICIENCIES WILL BE NOTED WITH A * BELOW.

- _____ Completed Application (signed by Applicant/Agent and notarized).
- _____ Copy of latest recorded deed indicating ownership of parent tract.
- _____ A scaled concept plan, drawn on the signed/sealed survey, graphically indicating the lot and leased area, total tower height including antennas, type and design of the tower structure, the boundary of the tower facility, all applicable setbacks (both on-site and off-site), ingress/egress, landscaping areas, and zoning of the subject property and adjacent property;

Factors to be considered shall be included on the Site plan:

- _____ Height of the proposed tower;
- _____ Distance of the tower to residential structures and residential zoning district boundaries;\
- _____ Distance from all adjacent municipalities and counties;
- _____ Nature of uses on adjacent and nearby properties;
- _____ Topography of the site and its effect on the efficiency of the tower in terms of coverage;
- _____ Surrounding tree coverage and foliage and its effect on the efficiency of the tower in terms of coverage, as well as, its effect on the visual impact of the tower on surrounding properties and streets;
- _____ Design of the tower, with particular reference to design characteristics that have the effect of reducing or eliminating visual obtrusiveness;
- _____ Proposed ingress and egress; and
- _____ The degree of the tower's compliance with the one statute mile separation (inside the highway corridor) or 1½ statute mile separation (outside the highway corridor).

NOTE: In granting its approval to waive or reduce requirements, the county, through the board of commissioners or its designee, may impose conditions that are necessary to minimize the adverse effect of a proposed tower or antenna on adjoining property. A site application shall be submitted within 60 days of the date of approval by the board of commissioners or the proposed tower will no longer be deemed a planned tower.
