- 1. Call to order by Committee Chair Donna Thompson**  
Donna Thompson called the meeting to order at 7:00 p.m.

- 4. Report from Committee Chair of preparations of materials for Board of Commissioner approval requests.**

## **5. Discussion of Scarecrow Project promotion and procedures of the event.**

Heather Cap will lead the Scarecrow Project. Build days are October 15 & 16. Committee members are asked to sign up for a block of time to help. The judge will come from out of the county. October 29<sup>th</sup> from 5 to 6pm there will be an awards ceremony at the complex.

The committee felt that to do this project well and take it up a notch, the planning should start months in advance, not the few weeks we have. Since this is an annual project, and now that the new committee has completed initial tasks that can be achieved in the following years' events.

Vote to move forward with the project, 9-0 in favor.

Donna Rosser stated the need for the committee to develop an email list to promote all events and invite participation.

## **6. Discussion of Birdhouse Project promotion and procedure of the event.**

Robert Johnson made a motion to open discussion. Rich Brown seconded.

Plan is to partner with other entities in the county. Jeff Mellin mentioned the enthusiasm in Tyrone for the event. Brand – tagline – “Art is Home in Fayette”. Need for a hashtag and Facebook page to act as a landing point for interested parties; share birdhouse facts, plans, ideas. Each house can be registered with the county and receive a number and an “Occupancy Permit” for the owner.

Ideas: high school seniors paint their parking spaces, create a survey for residents and one for students to see what they would like to see, build on the “Art is Home in Fayette” brand to create interest in residents collecting art of all kinds and price points, invite art principals from the Atlanta area for a lecture series to boost idea of collecting and learn more about art – collecting, displaying, curating a collection in their homes. Rich Brown wants us to be mindful of other arts – music, performance, spoken word.

Donna Thompson asked the committee to come prepared to discuss more ideas for projects at the next meeting.

## **Other Business**

Tina Brown made a motion to discuss Other Business. Heather Cap seconded.

Donna Thompson reported on an allegation (several emails/one author) claiming the committee had gathered without public notice (unpublicized meetings, social or otherwise).
