- 1. Call to order by Committee Chair Donna Thompson**  
Donna Thompson called the meeting to order at 7:00 p.m.
  - 2. Acceptance of agenda.**

It takes about six months to get it all planned. This exhibit and entries from local high school students would be juried in by one juror who would also judge the work for awards. The Committee needs to identify a location. Exhibit tentatively a spring event. More discussion at the next meeting.

Donna Rosser made a motion to end discussion. Seconded by Jeff Mellin. Motion passed 9-0.

**9. Discussion: plein air painting event in Fayetteville.**

Tina Brown made a motion to open discussion. Rich Brown seconded.

Donna Rosser explained the event could be one day, a weekend, or for a week. Artists in one location or in multiple locations around the county. Work is created onsite and gathered for judging and a sale at the end of the event. This event would be in the September.
