Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced Request for Quote. You will need to consider this information when preparing your quote.

1. How early can we start the work? Work can begin as early as 7:00a.m. Monday through Friday.
2. What is the latest we can work? The contractor may work as last as 9:00 p.m., Monday through Thursday, and until 6:00 p.m. on Fridays and Saturdays.
3. Are we painting the quarter round? Yes. All quarter round boarding the new floors will be replaced and painted.
4. The flooring in the scope of work is residential, does the county want to upgrade to industrial flooring? Thank you for bringing this to our attention. The correct product to quote is Roppe item 28wp6p3p045 is the Northern Timbers Premium Vinyl Planks in the **Steely Ash (045)** colorway, featuring a 6" x 48" dimension and a heavy-duty commercial construction.
5. Do you want the quarter round replaced around the stage? The quarter round is replaced where all new flooring is.
6. Will the three thresholds be replaced? The threshold in the front outside door will not be replaced, install new transitions for the hallway entrance and the back door exit.---
7. Is the current flooring glued? Yes, glued and locked.
8. Can we park a dumpster in front? Yes, a 20 yard can be parked in front of the double doors. A 30 yard dumpster is to big for that area.
9. The color number provided corresponds to a floating LVP, but the written notes underneath recommend a glue-down installation. Since these are two different installation systems, could you please clarify which method, and material should be used for this project? Thank you for bringing this to our attention see question #4

10. Are there any prevailing wage requirements applicable to this project? **No.**
11. Are there any limitations on subcontracting that bidders should be aware of? **Any subcontractor must give references for floor installation.**
12. Are any bid bonds, performance bonds, or payment bonds required for this solicitation? **No.**

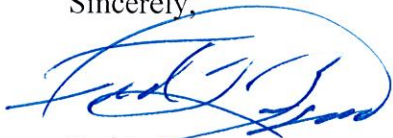
