Currently it is not being cut during the off season, so it not being serviced by our vender at this time due to it being the off season.

15. Can we move another day if it rains?

Yes, if it's being communicated and worked out with the appropriate County staff.

17. If a broken limb falls, does the County remove it?

If it is a small branch and it is in the way of mowing, the contractor is responsible for moving it. But if it is too large to be moved, contact the correct County Staff and they will remove it.

18. What is the earliest we can start cutting?

When it is light enough for the contractor to see.

19. What if the Scope of Work changes during the contract term?

A change order will be made and the Contractor will be notified.

20. Do you want the fence and gate around the retention pond sprayed?

No.

21. Does the County maintain the retention pond?

Yes.

22. What is the edging standard you are looking for?

That all areas that are to be edged are maintained and no grass is over the concrete.

23. When you saying 3" width for spraying, do you mean total or 3" on each side of the fence?

3" on each side of the fence.


