Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced **RFQ**. You will need to consider this information when preparing your quote.

1. **Attached is the updated Price Sheet.** Please note that only the updated Price Sheet will be accepted as your official quote.
2. **Would it be possible to move all the tree debris to the designated area and mulch them with a forestry mulcher? Chippings will be less consistent in size, but it would enable us to move more efficiently and will allow us to mulch all of the tree including the large diameter logs resulting in no haul off.**
The County will speak with the awarded contractor regarding this.
3. **Can we leave the stump mulch where it's at?**
Yes, the stump mulch may remain in place at the original stump locations.
4. **Where is the septic located?**
The septic is located on the opposite side of the building from where the work is being done. Looking at the building from the driveway it would be the left side.
5. **Will anyone be onsite before we begin work?**
Yes, the successful bidder will be required to attend a pre-work meeting with the County, and staff will be onsite when work begins.
