Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced ITB. You will need to consider this information when preparing your bid.

- 1. Can the County please provide the start and end points for each road? Several of the roads just state lengths, instead of starting and ending points.
 - a. Flat Creek Trail SR 54 to Tyrone Road
 - b. Bethea Road SR 314 to Longview Road
 - c. Bohannon Road Fulton County Line to Fulton County Line
 - d. Kirkley Road SR 74 to Bohannon Road
 - e. Lester Road SR 54 to Fayetteville City Limits and Fayetteville City Limits to Ebenezer Church Road
 - f. Tyrone Road SR 54 to Town of Tyrone City Limits
 - g. Kenwood Business Park (Carnes Drive, Cecil Court, Ethan Drive, Etowah Trace, Marksmen Court, Tober Trail and Walter Way) entrances off of SR 85 and Old Road.
- 2. Could you provide start/end points for the roads listed? See question #1.
- 3. Will a MTV(Shuttle Buggy) be required on any of the roads in this project? An MTV will be required on all roads except the roads within the Kenwood Business Park (Carnes Drive, Cecil Court, Ethan Drive, Etowah Trace, Marksmen Court, Tober Trail and Walter Way).
- **4. Are we required to use post mounted or tripod signs?** The contractor will have the option to use either method.
- 5. Could you clarify what the "grading per mile" consist of? What does the 5.61 miles define on this project? The miles do not match what is required for shoulder building as stated on the road list. Grading should be 14.72 miles to match the road list. Please use the attached updated Price Sheet (Attachment 1).
- 6. Are temporary warning signs okay to use for this project in place of post mounted signs? See question #4

- 7. On the roads that are getting an FDR treatment, will wet curing be okay or will prime and sand be required? As long as it meets GDOT specifications wet curing will be acceptable.
- 8. Could you give us the beginning and end points for all the roads on this contract? See question #1.
- 9. Will the county want to edge mill or full width mill the roads in this contract? Each road estimated milling needs are estimated under Section T of the bid document.
- 10. Can road widths please be provided?
 - a. Flat Creek Trail Estimated 25'
 - b. Bethea Road Estimated 20'
 - c. Bohannon Road Estimated 20'
 - d. Kirkley Road Estimated 22' & 20'
 - e. Lester Road SR 54 to Fayetteville City Limits and Fayetteville City Limits to Ebenezer Church Road. Section #1 Varies 95' to 36', Section #2 20'
 - f. Tyrone Road Estimated 24'
 - g. Kenwood Business Park (Carnes Drive, Cecil Court, Ethan Drive, Etowah Trace, Marksmen Court, Tober Trail and Walter Way) entrances off of SR 85 and Old Road. Estimated 24'
