Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced **RFQ**. You will need to consider this information when preparing your quote.

1. How does the vendor quote traffic control not provided by others? (pg. 12) **The vendor shall enter a quote to supply traffic control for testing services when they can't be supplied by others (County staff, Active Contractor work zone, etc...), Revised Price Sheet attached.**
2. On page 12, it mentions a group of 3 cylinders – please confirm that these cylinders are asphalt cores. **These cylinders are for testing the PSI strength after FDR is installed.**
3. Do the inspectors require any specific certifications? **We are not requiring inspectors to have the appropriate nuclear gauge certification, an extensive reference check will be performed.**
4. On page 12 under FDR Specifications (Bullet 2), it states that the mix-design provided by the contractor will be verified by the vendor. What type of verification is needed? **The contractor shall provide a 3rd party verification of the proposed Mix-Design prepared by the FDR Contractor per GDOT Spec 315 for the County is acceptable.**


