Addendum #1

Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced RFP. You will need to consider this information when preparing your proposal.

1. The RFP indicates turning movement counts for selected intersections and identification of intersections with capacity or operational needs. Is there an identified number of intersections for which traffic analysis is required?

We do not have a pre-set list of intersections for which turning movements and traffic analyses are required. Rather, County staff anticipates identifying the appropriate locations with the project team after existing data have been reviewed. For budgeting purposes, assume a minimum of four (4) turning movement counts at intersections and six (6) sets of 24-hour traffic counts along corridors. Vendors may propose more locations and/or alternate strategies for satisfying the fundamental questions of identifying future corridor and intersection capacity needs as explained in the RFP (see "Large Project Cumulative Traffic Impacts Since 2019").

2. The RFP references two rounds of pop-up events. Should we assume a specific number of events per round for the purposes of preparing the cost estimate?

Like the above question about the number of intersections, the actual number and location of "pop-up" events will be set by the project team and County staff based on input from the Stakeholder Committee and development of the Public Engagement Plan. For the cost estimate, assume a minimum of four locations for each of the two rounds (eight total).

3. The RFP specifies that costs are to be provided in year-of-expenditure dollars. The previous CTP presented all costs in current-year (2018) dollars. We understand that costs should reflect 2025 dollars, but should each phased project also be presented in its specific year of expenditure (e.g., a project recommended for 2035 shown in 2035 dollars)?

Yes, planning level project cost estimates should be provided in current and implementation year dollars. This is a requirement of Fayette County's agreement with ARC. For simplicity, Fayette County anticipates the projects will be grouped into short, mid, and long-term categories so common inflation/escalation rates can be provided for projects within the same category.

4. Also, can you confirm that the RFP/addenda will post on the Fayette County website and on Georgia Procurement Registry? In checking for addenda yesterday, I only saw it on GPR, but not the County website. Is this the correct link to check? Fayette County Invitations for Bids and Requests for Proposals.

Fayette County is in the process of updating our websites. Vendors should use the Georgia Procurement Registry to check the status of all solicitations.


