Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced RFQ. You will need to consider this information when preparing your quote.

1. The road segment description on Greenville Road says from Sourwood Trail to Rising Star Road is 0.50 centerline miles. If the centerline miles are right, should it not go from Sourwood Trail to Goza Road?  
*A correction for Old Greenville is Goza Road to Sourwood Trail, which is .50 CLM*
2. Is all Alligator cracking to be Crack Sealed?  
*Yes, all Alligator cracking areas are to be crack sealed.*
3. I am reviewing the Fayette County Crack Sealing plan for FY26. The only question I have is Old Greenville Rd (Sourwood Tr to Rising Star Rd) as it states it is only .5 miles. After reviewing it appears that the length is around 3.3 Miles. I wanted to make sure that I am not missing anything and should proceed to quote for the 3.3 mile length.

4. Could you send me the results from the 2025 crack seal bid please.


