### **Call to Order**

Chairman Brown called the December 11, 2014 Board of Commissioners meeting to order at 4:04 p.m. Chairman Brown also asked members of the audience for a show of hands for those planning to go to Broadway Diner for Commissioner McCarty's Appreciation Dinner, and twenty-eight people indicated that they would attend the dinner.

### **Invocation by Commissioner McCarty**

Commissioner McCarty introduced Pastor Bruce Black and asked him to offer the Invocation. Pastor Black offered the Invocation.

### **Pledge of Allegiance**

Commissioner McCarty led the audience in the Pledge of Allegiance.

### **Acceptance of Agenda**

Chairman Brown moved to accept the Agenda as written. Commissioner McCarty seconded the motion. No discussion followed. The motion passed unanimously.

**PROCLAMATION /RECOGNITION:**

**1. Recognition of Commissioner Allen McCarty for his years of service on the Fayette County Board of Commissioners.**

Chairman Brown and the Board recognized and honored Commissioner McCarty for his years of service on the Fayette County Board of Commissioners. A copy of the request, identified as "Attachment 1," follows these minutes and is made an official part hereof.

**2. Shop Fayette County for the Holidays.**

Commissioner Oddo read a proclamation calling on all citizens to Shop Fayette County for the Holidays. Copies of the request and proclamation, identified as "Attachment 2," follow these minutes and are made an official part hereof.

**3. Recognition and rewarding of the County Department who won Fayette County's Annual Door Decorating Contest.**

County Administrator Steve Rapson recognized and rewarded the Tax Commissioners Office and Public Works Departments who tied for first place, and he recognized and acknowledged the Fayette County Water System for winning second place in the contest. Representatives from the winning departments told the Board and audience of their door decorations. A copy of the request, identified as "Attachment 3," follows these minutes and is made an official part hereof.

**PUBLIC HEARING:**

**4. Public Hearing on staff's request to approve a transfer of license for Sequoia Golf Whitewater, LLC, from Mr. Joseph I. Guerra to Mr. Stephen Soriano for on-premises malt beverage, wine, and distilled spirit sales.**

Code Enforcement Officer Kathy Hobbs informed the Board that all the required paperwork was submitted, that the company would change hands on January 1, 2015, and that this involved a continuing license that was in good standing.

No one spoke in favor of or in opposition to this request.

Commissioner Oddo moved to accept staff's request to approve a transfer of license for Sequoia Golf Whitewater, LLC, from Mr. Joseph I. Guerra to Mr. Stephen Soriano for on-premises malt beverage, wine, and distilled spirit sales. Commissioner McCarty seconded the motion. No discussion followed. The motion passed unanimously. A copy of the request, identified as "Attachment 4," follows these minutes and is made an official part hereof.

5. **Public Hearing on Petition No. 1238-14, Sohel Dhanani, Owner, request to rezone 34.277 acres from A-R to R-40 to develop a Single-Family Residential Subdivision consisting of 19 lots, with said property being located in Land Lots 222 and 227 of the 13<sup>th</sup> District and fronting on Westbridge Road. The Applicant has requested to withdraw Petition 1238-14.**

Community Development Director Pete Frisina explained to the Board why the applicant asked to withdraw Petition No. 1238-14. Mr. Frisina anticipated this petition would return to the Board at a later date.

No one spoke in favor of or in opposition to Petition 1238-14.

Commissioner Ognio moved to approve the withdrawal of Petition No. 1238-14. Commissioner McCarty seconded the motion. No discussion followed. The motion passed unanimously. A copy of the request, identified as "Attachment 5," follows these minutes and is made an official part hereof.

6. **Public Hearing of Petition No. 1240-14, Davis, LLC, Owner, and Rick Halbert, Agent, request to rezone 63.89 acres from A-R and R-40 to A-R to develop Single-Family Residential, with said property being located in Land Lots 5 and 6 of the 7<sup>th</sup> District and fronting on Davis Road.**

Community Development Director Pete Frisina briefed the Board on Petition 1240-14. He stated that this request is a housekeeping rezoning. He said the acres in question were zoned mostly as A-R but a small portion of the acres was zoned R-40. He stated that the applicant could build on the property only after it was zoned for one zoning district.

No one spoke in favor of or in opposition to Petition 1240-14.

Commissioner Oddo moved to accept Petition No. 1240-14, Davis, LLC, Owner, and Rick Halbert, Agent, request to rezone 63.89 acres from A-R and R-40 to A-R to develop Single-Family Residential, with said property being located in Land Lots 5 and 6 of the 7<sup>th</sup> District and fronting on Davis Road. Commissioner McCarty seconded the motion. No discussion followed. The motion passed unanimously. Copies of the request, Rezoning Ordinance 2040-14, and Rezoning Resolution 2040-14, identified as "Attachment 6," follow these minutes and are made an official part hereof.

7. **Public Hearing on proposed Ordinance 2014-19, amending the Fayette County Code of Ordinances, Chapter 110. Zoning Ordinance, regarding Greenhouses in Section 110-3. Definitions, Section 110-79. Accessory Structures And Uses, Section 110-125. A-R Agricultural-Residential District, and Section 110-169 Conditional Use Approval.**

Community Development Director Pete Frisina briefed the Board on the proposed amendments and answered questions from the Board. He reminded that Board that this discussion began in March 2014. He stated that this subject had been reviewed by the Planning Commission. He reminded the Board that this discussion first began with a discussion on hoop houses. Mr. Frisina explained that the hoop houses were now under two categories. Specifically, he said the hoop houses would be categorized as either temporary or permanent greenhouses. Mr. Frisina then explained what the difference was between a permanent greenhouse as opposed to a temporary greenhouse. Mr. Frisina then informed the Board of the proposed regulations for having and maintaining the hoop houses, and of the various changes in the proposed ordinance. Mr. Frisina closed his presentation by telling the Board why Mr. Jim Graw of the Planning Commission opposed the proposed amendments.

No one spoke in favor of or in opposition to the proposed amendments.

Commissioner Oddo asked how complex was the process for submitting applications to construct a greenhouse. Mr. Frisina stated that he tried to make the application process easy and he explained what kind of information could be provided in the application.

Commissioner Ognio moved to adopt Ordinance 2014-19, amending the Fayette County Code of Ordinances, Chapter 110. Zoning Ordinance, regarding Greenhouses in Section 110-3. Definitions, Section 110-79. Accessory Structures and Uses, Section 110-125. A-R Agricultural-Residential District, and Section 110-169 Conditional Use Approval. Commissioner McCarty seconded the motion. No discussion followed. The motion passed unanimously. Copies of the request and Ordinance 2014-19, identified as "Attachment 7," follow these minutes and are made an official part hereof.

9. **Approval of staff's recommendation to enter into a contract with The Carl Vinson Institute of Government at the University of Georgia to conduct a classification and compensation study of the Information Technology Department and up to six positions, beginning January 21, 2015, with a cost estimate submitted for review in May 2015 and a final report submitted in June 2015 at a cost of \$3,500. Commissioner McCarty moved to approve the reappointment of Marie Washburn as the City of Peachtree City's representative on the Fayette County Library Board for a four-year term beginning on January 1, 2015 and expiring on December 31, 2018. Commissioner Oddo seconded the motion. No discussion followed. The motion passed unanimously. A copy of the request, identified as "Attachment 16," follows these minutes and is made an official part hereof.
18. **Consideration of the reappointment of Lisa Richardson as the Town of Tyrone's representative on the Fayette County Library Board for a four-year term beginning on January 1, 2015 and expiring on December 31, 2018.**  
  
Commissioner Barlow moved to accept the reappointment of Lisa Richardson as the Town of Tyrone's representative on the Fayette County Library Board for a four-year term beginning on January 1, 2015 and expiring on December 31, 2018. Commissioner McCarty seconded the motion. No discussion followed. The motion passed unanimously. Commissioner Ognio moved to accept the reappointment of Kim Bradley as the Town of Brook's representative on the Fayette County Library Board for a four-year term beginning on January 1, 2015 and expiring on December 31, 2018. Commissioner Barlow seconded the motion. No discussion followed. The motion passed unanimously. A copy of the request, identified as "Attachment 18," follows these minutes and is made an official part hereof.

20. **Consideration of the Selection Committee's recommendation to appoint Mr. Darryl Paul to the Fayette County Ethics Board for a three-year term beginning November 8, 2014 and expiring November 7, 2017.**

Commissioner Oddo moved to accept the appointment of Mr. Darryl Paul to the Fayette County Ethics Board for a three-year term beginning November 8, 2014 and expiring November 7, 2017. Commissioner Ognio seconded the motion. No discussion followed. The motion passed unanimously. A copy of the request, identified as "Attachment 19," follows these minutes and is made an official part hereof.

21. **Consideration of Commissioner Ognio's recommendation to adopt Resolution 2014-19 requesting the Fayette County Legislative Delegation to consider offering changes to the statute governing the use of fluoride in drinking water.**

Chairman Brown stated that there was an additional document on the dais and that it was available through the County Clerk's Office. He stated it was a letter from the Department of Health and Human Services, dated October 21, 2000, and addressed to Honorable Ken Calvert, Chairman of the Subcommittee on Energy and Environment Committee on Science in the House of Representatives.

Chairman Brown read Resolution 2014-19 into the record. The resolution read as follows:

### *RESOLUTION 2014-19*

### *RESOLUTION REQUESTING THE FAYETTE COUNTY LEGISLATIVE DELEGATION TO CONSIDER OFFERING CHANGES TO THE STATUE GOVERNING THE USE OF FLUORIDE IN DRINKING WATER*

WHEREAS, *The Fayette County Board of Commissioners has held several public discussions pertaining to the use of fluoride in drinking water which is mandated by the State of Georgia; and*

WHEREAS, *Noting that a number of Western European countries have elected not to fluoridate their drinking water; nevertheless, there is little statistical difference in tooth decay numbers compared to the U.S. ; and*

- WHEREAS, *Fluoride is classified as a drug that is subject to U.S. Food and Drug Administration regulation, and quantity of consumption cannot be accurately controlled, especially by young children; and*
- WHEREAS, *Many are in agreement with Swedish Nobel Laureate and Professor of Pharmacology Arvid Carlsson that fluoride is readily available commercially in a multitude of products, so the government should not have to force fluoride on anyone; and*
- WHEREAS, *The Centers for Disease Control and Prevention, October 22, 1999, stated that the predominate benefit from fluoride is through topical application and most fluoride is water ingested; and*
- WHEREAS, *Many homeowners in Fayette County utilize well water that has no added fluoride and no evidence has yet to be provided where those drinking from a well have more tooth decay than those who do not; and*
- WHEREAS, *In the existing statute, the petition requiring 10 percent of the registered voters from the previous general election to remove fluoride seems overly burdensome; and*
- WHEREAS, *The Fayette County Board of Commissioners believes "home rule" is important and that the citizens should be allowed to control their own destiny, especially related to drugs or other substances added to their drinking water;*

*BE IT THEREFORE RESOLVED THAT the Board of Commissioners of Fayette County does hereby request that our county Legislative Delegation to act to remove the burden of the "petition of 10 percent of the registered voters in such political subdivision who voted in the last general election" from the existing statute and allow counties and cities who supply water to simply call for a referendum of their citizens.*

*So resolved this 11<sup>th</sup> day of December 2014, by the*

Commissioner Ognio stated that this resolution was a first step toward enabling citizens to vote whether or not they want fluoride in the water system. Chairman Brown added that it would give the citizens an ability to simply vote without having to garner ten percent support of the population, as is currently required.

Chairman Brown moved to approve the adoption of Resolution 2014-19 requesting the Fayette County Legislative Delegation to consider offering changes to the statute governing the use of fluoride in drinking water. Commissioner McCarty seconded the motion. No discussion followed. The motion passed unanimously. Copies of the request and Resolution 2014-19, identified as "Attachment 20," follows these minutes and is made an official part hereof.

**22. Consideration of Commissioner McCarty's recommendation to prominently display the national motto, "In God We Trust," in the Board of Commissioners' Public Meeting Room.**

Commissioner McCarty explained that the motto "In God We Trust" is all over Washington D.C., it is displayed in the United States Supreme Court, and it is printed on our money. He stated that America was founded on its trust in God, and he recommended that this motto be prominently displayed in the Public Meeting Room as requested. He closed his comments by asking, "If it is not in God we trust then who is it?"

Commissioner Ognio moved to approve Commissioner McCarty's recommendation to prominently display the national motto, "In God We Trust," in the Board of Commissioners' Public Meeting Room. Commissioner McCarty seconded the motion.

Chairman Brown asked how and where the motto would be placed in the meeting room. County Administrator Steve Rapson replied that staff would take two or three attempts to run it by the Board for approval.

The motion to approve Commissioner McCarty's recommendation to prominently display the national motto, "In God We Trust," in the Board of Commissioners' Public Meeting Room passed unanimously. A copy of the request, identified as "Attachment 21," follows these minutes and is made an official part hereof.

**PUBLIC COMMENT:**

**Alice Jones:** Mrs. Jones thanked Commissioner McCarty for his service and working with the citizens in North Fayette County. She hoped that Commissioner-elect Coston would serve the citizens well and would be respected. She stated that Commissioner-elect Coston would bring beauty to the Board of Commissioners. Mrs. Jones stated she was very hurt to hear the racist overtones and racial remarks at the last County Commission meeting. She informed the Board that she is a law-abiding citizen and a taxpayer, and that she leaves her money up to the Board of Commissioners and to the Fayette County Board of Education to utilize the money she pays to help benefit all of the citizens equally and to treat them with equal respect. Mrs. Jones said that when she and others are referred to as "you people" and that "you're not qualified" that she was as qualified as anyone else. She told the Board that she has degrees, has worked in accounting and finances, and that she has taught in school and in college. She said she has done many things in her life, and therefore she was equally qualified to serve in various capacities. She stated that when former Commissioners ran for the office, they ran as Republicans and she voted for them and supported them financially. She said it did not matter to her whether or not her commissioners were Democrats or Republicans, and that it was hurtful to hear Democrats referred to as "demoncrats." Mrs. Jones stated that everyone needs to work together with the same opportunities to be served and be respected. She explained that she does not look at people based on color. She stated that irrespective of race, be it white or black, she will go to someone's rescue, and she hoped they would do the same for her. Mrs. Jones stated that people needed to put aside their personal views and traditions that they have grown up with since the people need to work together as a county. Mrs. Jones stated that the young people are coming together apart from race, but they will not come to Fayette County if the people are unwilling to change.

**Roy Bishop:** Mr. Bishop asked Chairman Brown how the district voting became legal. He added that whoever drew the district map must have been in the first grade. He added that the County Commissioners and its administration have done well for the past two years and he congratulated everyone for their work. Mr. Bishop stated that he was sorry to see Commissioner McCarty leave office.



**Mayor Greg Clifton:** Mr. Greg Clifton, mayor of the City of Fayetteville, wished the Board a Merry Christmas. He thanked the Board for allowing the city to use the fountain at Heritage Park for the parade and tree lighting ceremony. He said the city enjoyed working with the county this year. He wished Commissioner McCarty well and stated that he looked forward to working with Commissioner-elect Coston and the new Board next year. He concluded saying that the city and county have a great working relationship and he did not anticipate any changes in the relationship.

**Frank Gardner:** Mr. Gardner said it did not "give me any privilege to recommend what I'm going to say." He stated that every day since the last meeting, he has been trying to put into words what to say without putting himself into the same category of talking down to people who do not agree with him. Mr. Gardner stated: "My Commissioner made it plain that he didn't represent me, and with those words I will have to ask for him to resign." He thought that Commissioner Barlow knew what he was responding to. Mr. Gardner then read a quote from the newspaper and commented on their application.

Chairman Brown pointed out that Council Members Mickey Edwards and Paul Oddo, of the City of Fayetteville, were in the audience and he thanked them for coming to the meeting.

**Darryl Paul:** Mr. Darryl Paul thanked the Commissioners for his appointment to the Fayette County Ethics Board.

#### **ADMINISTRATOR'S REPORTS:**

**Swearing-in Ceremony for Commissioner-elect Pota Coston:** County Administrator Steve Rapson reminded everyone that Commissioner-elect Pota Coston would be sworn into office on Friday, January 2, 2015 at 4:00 p.m.

**County Offices Closed for the Christmas Holiday:** County Administrator Steve Rapson stated that, based on the Board's vote earlier in the meeting, the County's Administrative Offices would be closed from Wednesday, December 24, 2014 through Friday, December 26, 2014. He stated notices would be posted regarding the closures.

**Dinner at Broadway Diner:** County Administrator Steve Rapson stated that there would be a dinner at Broadway Diner at 6:00 p.m. in recognition of Commissioner McCarty's service to Fayette County.

#### **ATTORNEY'S REPORTS:**

**Notice of Executive Session:** County Attorney Dennis Davenport stated that he had two items for discussion in Executive Session. He said the first item involved Threatened Litigation and the second item involved Pending Litigation.

#### **COMMISSIONERS' REPORTS:**

**Commissioner Barlow:** Commissioner Barlow stated he had spoken extensively with Mr. Bloom who was sitting in the audience, and that he told Mr. Bloom that he would publically read the apology that he sent to the newspapers. He stated that Mr. Bloom had informed him during the conversation that he might not come to the meeting since he was satisfied with the conversation that was had by phone. Commissioner Barlow then read his apology concerning his comments on November 13, 2014 into the record. He also thanked Attorney Wayne Kendall for the encouraging words that he sent to him. He said Mr. Kendall's comments were heartwarming when he said, "You've had a hard week, brother. I know what you meant and what was said was not what you meant. You've apologized, now let's move on." Commissioner Barlow stated that if you kneel before God you can stand before anyone. He added that

what God knows about him is more important than what others think about him. Commissioner Barlow thanked the County's staff and particularly County Administrator Steve Rapson for a wonderful year in 2014. He said the staff was the best at what they do, and he was honored to be a part of this great county. He noted that his wife was in the audience before he wished everyone a Merry Christmas and asked God to bless Fayette County and the United States of America.

**Commissioner Oddo:** Commissioner Oddo remembered those who are defending our nation. He said the nation is a great nation since it has overcome obstacles that other nations have not been able to do. He wished everyone, especially those in the military, a Merry Christmas and a Happy New Year. Commissioner Oddo also thanked Commissioner McCarty for his years of service on the Board of Commissioners, and he asked Commissioner McCarty to come back to the meetings. He also congratulated Commissioner-elect Coston and stated that she would "put a bright light in one of the seats."

**Commissioner Ognio:** Commissioner Ognio stated that he could not believe that he had been on the Board for two years and noted that "time flies." He said it had been an honor to serve the citizens for two years, and he thanked Commissioner McCarty for his years of service on the Board of Commissioners. Commissioner Ognio reminded everyone that this was the season of giving, and he asked people to reach out to those in need and give them a boost.

**Commissioner McCarty:** Commissioner McCarty stated that he wanted everyone to know that the past four years as Commissioner has been one of the best and most exciting things he has ever done in his life. He said it was one of the "funnest and most fulfilling things" he has done. He stated that every citizen of Fayette County is a great person. He stated that Fayette County is the best county in Georgia and in the nation. Commissioner McCarty stated that the County has the best staff that he has ever worked with anywhere, and that he cannot do anything but complement everyone he has worked with including the Commissioners that he has worked with during the last two years. He thanked everyone for what he has done.

Commissioner McCarty stated that there was one item of business that had not been done that should have been done, and that it involved the opening of the new county fire station. He stated that Fire Chief David Scarbrough had stated that there was one thing that he really needed. Commissioner McCarty said he agreed with the Chief and that the County was short of one fire engine.

Commissioner McCarty then moved to present the Fire Chief with a brand-new fire engine for his brand-new fire station, because that was really needed. Chairman Brown asked Commissioner McCarty if he was adding to the agenda by asking for the provision of a new fire truck and Commissioner McCarty stated that was what he was doing. Commissioner Oddo seconded the motion to present the Fire Chief with a new fire engine.

Commissioner Oddo asked if the fire engine could be worked into the budget. Commissioner McCarty stated he still pays taxes and that his taxes could be applied to the fire engine. Commissioner Barlow asked if this fire truck was a scale model or if it was the real thing. County Administrator Steve Rapson replied that it was real, and Commissioner Barlow replied that he would vote in favor of the motion.

The motion to present the Fire Chief with his new fire engine passed unanimously. Commissioner McCarty then produced a toy, plastic fire engine and presented it to Fire Chief David Scarbrough.

**Chairman Brown:** Chairman Brown stated that it had been an honor and privilege to work with Commissioner McCarty. He thought Commissioner Ognio was right since the last two years seem to have flown by, even though

their first two years felt more like ten years. He stated that Commissioner McCarty was a good guy who has a story or experience with nearly everything. He said he loved Commissioner McCarty's country charm that expands over different states and careers. Chairman Brown said it was a privilege to work with Commissioner McCarty. Commissioner McCarty thanked the Board saying if it were not for the Board he would not be able to get anything done.
