### A. CALL TO ORDER

# 2. ORDER ISSUED BY JUDGE TIMOTHY BATTEN

Mr. Davenport started out by saying he has not been involved in the lawsuit and did not attend the hearing on February 18, 2014 but he does have a copy of the order issued. Those attending the hearing, anticipating an opportunity to address the court on the issue of district voting, were not allowed to do so.

The end result of the hearing is that district voting is to be implemented with his order. It by definition is a final order, which has been anticipated for quite some time. He said that the order is appealable, but of course, he does not know whether that will happen. It

is in effect for the 2014 election cycle beginning with no time to spare, since qualifying is next week.

There was further discussion among the Board members relating to the map and how the Board of Education and the Board of Commissioners would be affected.

Mr. Davenport said he knew this was a short version of what happened but that is really all that happened. He said he would be happy to answer any questions about things he can answer questions about.

The Board indicated they did not have any questions. Mr. Davenport said this election is going forth under this map no matter what happens.

Supervisor Sawyer said the office is working diligently to implement the changes relating to the new district map. He said maps are being printed that will be available to the parties for them to use for qualifying next week. As soon as all changes are made in the database, new precinct cards will be mailed to all the voters.

Mr. Davenport reiterated that he would be happy to answer any further questions on this topic that the Board may have.
