#### A. CALL TO ORDER

Chairman Hicks called the November 15, 2016 Board of Elections meeting to order at 2:00 p.m.

1. The introduction and welcome of Floyd Jones, Fayette County Elections and Voter Registration Supervisor

Chairman Hicks and Mr. Wright introduced and welcomed Mr. Jones as the Fayette County Elections and Voter Registration Supervisor.

#### **B. APPROVE AGENDA**

Mr. Wright moved to approve the Agenda as published. Chairman Hicks seconded the motion. The motion passed 2-0 with Mr. Lester absent from the vote.

#### C. PUBLIC COMMENTS

**Leonard Presburg:** Mr. Presburg, Chairman of the Fayette County Democratic Committee, thanked the Elections Office including thanked Mrs. Crosby and Mrs. Combs for their diligent work during redistricting and the recently concluded presidential election. The Board thanked Mr. Presburg for his kind comments.

**Alberta Lucas:** Ms. Lucas referred to the October 2016 meeting where it was mentioned that the Fayette County schools would no longer be used as polling places, and she asked why that was a concern.

Chairman Hicks replied that the main reason concerned the security of the students since parents are concerned that voters are coming to the public schools; particularly middle schools and elementary schools. He explained that once the redistricting process occurs, all of these matters will be taken into consideration. He mentioned that the Superintendent of Schools has echoed the parents' concerns, but that he had asked the Superintendent to allow the schools to be used at least through the potential Special Purpose Local Option Sales Tax (SPLOST) election.

No one else spoke and the Public Comments portion of the meeting was closed.

#### D. HEARING

#### 1. DECEASED ELECTORS

Chairman Hicks and Mr. Wright reviewed the Deceased Electors list. Mr. Wright moved to approve the list. Chairman Hicks seconded the motion. The motion passed 2-0 with Mr. Lester absent from the vote.

#### 2. FELONS

Chairman Hicks and Mr. Wright reviewed the Felons list. Mr. Wright moved to approve the list. Chairman Hicks seconded the motion. The motion passed 2-0 with Mr. Lester absent from the vote.

#### **E. OLD BUSINESS**

#### 1. MINUTES OF PREVIOUS MEETINGS

#### a. October 20, 2016

Chairman Hicks and Mr. Wright reviewed the October 20, 2016 Minutes. Mr. Wright moved to accept the October 20, 2016 Board of Elections Minutes as presented. Chairman Hicks seconded the motion. The motion passed 2-0 with Mr. Lester absent from the vote.

#### F. NEW BUSINESS

#### 1. Political Attire at the Polling Place

Chairman Hicks stated that this issue arose after someone wore an "Obama" shirt at the polls. He explained that the issue is not whether someone can campaign at the polls since it was understood that campaigning is not allowed at the polls. He said the issue was if it is considered campaigning if a person wears a political shirt when the candidate is not on the ballot. He suggested this was a legal question.

Mrs. Crosby stated that she and Mr. Jones had looked at the code and it appears that the Elections Code does not prevent someone from wearing political clothing so long as the candidate is not on the ballot. She stated that Chris Harvey mentioned that different counties set policy. She mentioned there was some ambiguity in how counties handle these matters.

Mr. Jones agreed that the code appeared to allow for political clothing to be worn for those who are not on a ballot, but there was some vagary with regard to political party wear. He mentioned there was a news article published about a week earlier that provided guidance from Mr. Harvey on the subject. He stated that once his office transition is completed, he would be able to find and provide that article.

Chairman Hicks asked that this item be added to the next agenda in order for the County Attorney to provide insight into the matter, to provide time to produce the news article that was mentioned, and to obtain Mr. Harvey's guidance.

Mr. Wright stated there he spoke to some friends and did some research, and that it appeared there was some consistency around the state that wearing a Democrat t-shirt or a Republican t-shirt is not acceptable since it is considered to be campaigning. He stated that to be consistent, even if the voters were wearing a "Deplorables" t-shirt or a "Dole /Kemp 96" t-shirt they were asked to cover them up. He stated that campaigning in any form is not permitted within 150 feet of the furthest edge of the building that is the precinct. He said the rule was applied consistently in Fayette County with no campaigning at all. He agreed that the Board could change how the rule is applied, but that Mr. Davenport's input would be welcomed.

Mr. Jones replied that he would reach out to Mr. Davenport about this matter. Mrs. Crosby stated that jewelry needed to be considered. Mr. Jones asked if people would have to take bumper stickers off their cars if they do early voting in the county's parking lot. Chairman Hicks added that on the Saturday of early voting the City held a fair on county property and at the fair there were people campaigning for their particular candidates. It was agreed that this topic would be on the next agenda.

#### 2. Certification of The November 8, 2016 General Election

Chairman Hicks asked to delay the certification of the election until the other items on the Agenda were addressed.

The Board reviewed provisional ballots and certified the November 8, 2016 General Election by 3:00 p.m.

#### **G. OTHER BUSINESS**

No other business was brought before the Board of Elections.

#### H. OTHER ITEMS FOR CONSIDERATION

No other items for consideration were brought before the Board of Elections.

#### I. ADJOURNMENT

After other business and other items were considered, Chairman Hicks announced that the Board would enter into the process of certifying the November 8, 2016 General Election.

Chairman Hicks further announced that the public meeting would be closed since the certification process involved going over people's personal matters.

Chairman Hicks thanked County Commission Chairman Charles W. Oddo for the approval of the Election's Agenda item and he thanked the Board of Commissioners for their support during the election.

Mr. Wright moved to adjourn the business portion of the meeting. Chairman Hicks seconded the motion. The motion passed 2-0 with Mr. Lester being absent from the vote.

The business portion of the meeting adjourned at 2:15 p.m.

#### WORDING FOR THE AGENDA

#### SPECIFIC ACTION / DIRECTION SOUGHT

County Attorney Dennis Davenport to provide legal insight into the matter of wearing political attire and campaigning at polling locations.

No specific action is sought from the Board of Elections.

#### **MINUTES**

#### A. NEW BUSINESS

#### 1. Political Attire at the Polling Place

Chairman Hicks stated that this issue arose after someone wore an "Obama" shirt at the polls. He explained that the issue is not whether someone can campaign at the polls since it was understood that campaigning is not allowed at the polls. He said the issue was if it is considered campaigning if a person wears a political shirt when the candidate is not on the ballot. He suggested this was a legal question.

Mrs. Crosby stated that she and Mr. Jones had looked at the code and it appears that the Elections Code does not prevent someone from wearing political clothing so long as the candidate is not on the ballot. She stated that Chris Harvey mentioned that different counties set policy. She mentioned there was some ambiguity in how counties handle these matters.

Mr. Jones agreed that the code appeared to allow for political clothing to be worn for those who are not on a ballot, but there was some vagary with regard to political party wear. He mentioned there was a news article published about a week earlier that provided guidance from Mr. Harvey on the subject. He stated that once his office transition is completed, he would be able to find and provide that article.

Chairman Hicks asked that this item be added to the next agenda in order for the County Attorney to provide insight into the matter, to provide time to produce the news article that was mentioned, and to obtain Mr. Harvey's guidance.

Mr. Wright stated there he spoke to some friends and did some research, and that it appeared there was some consistency around the state that wearing a Democrat t-shirt or a Republican t-shirt is not acceptable since it is considered to be campaigning. He stated that to be consistent, even if the voters were wearing a "Deplorables" t-shirt or a "Dole /Kemp 96" t-shirt they were asked to cover them up. He stated that campaigning in any form is not permitted within 150 feet of the furthest edge of the building that is the precinct. He said the rule was applied consistently in Fayette County with no campaigning at all. He agreed that the Board could change how the rule is applied, but that Mr. Davenport's input would be welcomed.

Mr. Jones replied that he would reach out to Mr. Davenport about this matter. Mrs. Crosby stated that jewelry needed to be considered. Mr. Jones asked if people would have to take bumper stickers off their cars if they do early voting in the county's parking lot. Chairman Hicks added that on the Saturday of early voting the City held a fair on county property and at the fair there were people campaigning for their particular candidates. It was agreed that this topic would be on the next agenda.

#### INTERGOVERNMENTAL AGREEMENT FOR CONDUCTING MUNICIPAL ELECTIONS

This Agreement entered into this \_\_\_\_\_ day of \_\_\_\_\_ 2017 between the CITY OF FAYETTEVILLE, a municipal corporation lying wholly or partially within Fayette County, Georgia, hereinafter referred to as "The City" and Fayette County, Georgia, a political subdivision of the State of Georgia hereinafter referred to as "The County". WITNESSETH: WHEREAS, the City in performance of its governmental functions will hold the elections hereinafter described; and, WHEREAS, under the provisions of the Georgia Election Code, particularly O.C.G.A. § 21-2-45 of the Official Code of Georgia Annotated, the City may, by ordinance, authorize the County to conduct such elections and the City has heretofore adopted such an ordinance; and WHEREAS, the County has staff and equipment to conduct such elections; and WHEREAS, the County desires to assist said City in the conduct of its municipal elections. NOW THEREFORE, for an in consideration of the premises contained herein, it is hereby agreed as follows: 1. This Agreement shall govern the conduct of the City of Fayetteville's general election to be held on November 7, 2017 and any and all run-offs which may be necessary and any special

elections that may occur within twelve (12) months of this Agreement.

Fayette County through the Fayette County Board of Elections shall operate as superintendent of the aforementioned elections and shall perform any and all functions of the City or any of the City's officials in connection with the conduct of such elections with the exception of duties pertaining to the qualification of candidates and pertaining to the responsibility of acting as the Qualifying Officer and providing notification to the State Elections Commission concerning candidacy compliance.

A City official shall operate as the Superintendent with respect to the qualification of candidates. Such official shall perform any and all functions of the City or any of its officials in connection with the qualifications of candidates in accordance with O.C.G.A. § 21-2-45(C)(2). Further, such official shall be responsible for acting as the Qualifying Officer and for notification to the State Elections Commission concerning candidacy compliance.

The County shall supply all of the necessary manpower and transportation to pick up, deliver, set up, store, and return to the County all of the voting equipment used in the elections along with all ancillary equipment and necessary supplies.

5.

All the voting equipment shall be programmed by the Center for Elections located at Kennesaw State University.

6.

All absentee ballots shall be ordered, issued, mailed, and accounted for by the County.

7.

Staffing for the polling locations and training of the staff shall be provided by the County.

8.

All expenses and charges incurred in the performance of said elections (except for the actual cost of the State-owned voting system and State-owned ancillary equipment) shall be the responsibility of the City. Said expenses and charges shall include but not be limited to the following: all costs of training and providing personnel for the elections, costs of printing, mailing and processing absentee ballots, the costs of expendable supplies and a pro-rated maintenance cost for the voting equipment. An invoice for the costs and expenses of the elections shall be submitted to the City and the City shall remit payment of the invoice to Fayette County within thirty (30) days of receipt of the invoice.

9.

To the extent permitted by law, the City shall indemnify, defend and hold harmless the County from any liability and/or litigation expenses to which the County may be subjected as a consequence of or as a result of the elections for the City. The City will furthermore, to the extent provided by law, reimburse the County for any and all necessary legal representation, by counsel chosen by the County, in any action arising from the conduct of the City elections. Said reimbursement shall be paid by the City within thirty (30) days of invoice by the County.

This intergovernmental contract is a full and complete statement of the agreement of the parties as to the subject matter hereof and has been authorized by proper action of the respective parties.

Should any provision of this Agreement or application thereof to any person or circumstance be held invalid or unenforceable, the remainder of this Agreement or the application of such provision to any person or circumstance, other than those to which it is held invalid or unenforceable, shall not be affected thereby, and each provision of this Agreement shall be valid and enforceable to the full extent permitted by law.

Should it be necessary to comply with any legal requirements, the necessary members of the County's personnel may be temporarily sworn in as officers and employees of the City.
