Mr. Wright moved to approve staff's request to appoint Mr. Eddie Stauber as Poll Manager for Precinct #36- Antioch for the November 7, 2017 municipal and Education Special Purpose Local Option Sales Tax (E-SPLOST) elections. Chairman Hicks seconded the motion. The motion passed 2-0 with Mr. Lester being absent from the vote. A copy of the request, identified as "Attachment 2," follows these minutes and is made an official part hereof.

4. Consideration of staff's recommendation to adopt the Fayette County Board of Elections By-laws.

No discussion was held pertaining to this request.

Mr. Wright moved to table staff's recommendation to adopt the Fayette County Board of Elections By-laws until the October 24, 2017 Board of Elections meeting. Chairman Hicks seconded the motion. The motion passed 2-0 with Mr. Lester being absent from the meeting. A copy of the request, identified as "Attachment 3," follows these minutes and made an official part hereof.

NEW BUSINESS:

5. Update concerning the disposition of Mr. John Kimbell and the State Board of Elections.

Director Jones read the supporting documentation belonging to this request into the record.

The Board did not take action or provide direction on this matter.

A copy of the request and its supporting documentation, identified as "Attachment 3," follows these minutes and is made an official part hereof.

DIRECTOR'S REPORT:

Georgia Government Transparency & Campaign Finance Commission: Director Jones reported that the Georgia Government Transparency & Campaign Finance Commission has tabled their discussion about proposed new rules pertaining to ethics reporting. Reportedly, the commission is weighing whether reporting agencies "shall" report at the end of each month or whether they "may" report at the end of each month.

<u>Staff Training on Balotar Equipment</u>: Director Jones reported that ES&S was at the county earlier today training staff on the Balotar System and how to produce provisional ballots.

<u>Early Voting Dates and Times</u>: Director Jones reminded the Board and audience that the Absentee In-Person election begins on Monday, October 16 and extends through Friday, November 3.

Discussion on Opening the Municipal and Special Election for Saturday Voting: Director Jones stated that an email had been sent from Mr. Neil Sullivan asking for early voting to include a Saturday for those who are unable to vote throughout the week. He added that the email pointed out some of the issues involving two elections held simultaneously- particularly with some voters having to go to two different locations to vote on the city and county question.

Minutes September 26, 2017 Page Number 3

It was pointed out that any additional cost for opening on Saturday would be charged back to the Board of Education as well as to the City of Fayetteville, the City of Peachtree City, and the Town of Tyrone. It was further pointed out that absentee voting by mail was available for 21 days since this involved a municipal election. It was agreed upon that a decision would have to be made at this Board of Elections meeting since the next meeting, held in October, would be too late.

Director Jones stated there had been some consideration about having only one early voting location open for three weeks with the remaining two voting locations being opened for one week. He explained that this consideration was based on expected low-voter turnout. He stated that the reason all three voting locations were opened for all three weeks was due to the ESPLOST question being presented to the voters; meaning- from that perspective- there were two extra weeks available at two separate sites for anyone who wants to vote.

It was understood that if Saturday voting was agreed upon it would likely interfere with events that the City of Fayetteville has already scheduled for the County's Administrative Complex, and it would make voting on that Saturday problematic.

Mr. Wright asked if the early voting hours could be shifted, for instance, from 10 a.m. until 7 p.m. Considerable discussion followed about this matter but it was understood that early voting had to occur during normal business hours from 8 a.m. until 5 p.m., but that the hours could be extended should the Board decide to do so. It was further understood that extending hours would involve overtime for staff.

Mr. Wright asked County Attorney Dennis Davenport if this a decision that Mr. Jones could make or was it a Board decision. Mr. Davenport replied this is a Board decision.

Chairman Hicks stated he wanted to give staff the latitude to decide on how to provide greater access. Mr. Wright added that whatever decision is made it would have to be consistent on a go-forward basis for future elections. Chairman Hicks pointed out that extending hours could provide greater than one day for people to vote outside of normal business hours. Considerable discussion continued.

Mr. Wright stated that a broad conversation was in order for this matter, but he was not necessarily in favor to have Saturday voting this time. He said he thought the topic would have to be thoroughly researched and that it would have greater impact at larger elections. Chairman Hicks added this was an opportunity to take this step in order to serve the people. Mr. Wright stated he wanted to know what the changes involved before making the change.

Chairman Hicks stated this was an opportunity of being proactive. He asked, if extending hours failed, what would be the cost. He asked Mr. Davenport if it was a proper motion to either shift or extend the voting hours unless staff returns stating it would cause a problem would it be acceptable. Mr. Davenport advised that the motion should not have qualifications. Mr. Davenport stated the motion would need certainty. Director Jones added that if a motion was made to extend hours only for staff to find out that it cannot extend hours, then mixed messages would be sent to the public regarding voting hours.

Chairman Hicks stated that this was a perfect opportunity to make a change. Mr. Wright replied that he was not willing, based on one email, to make a decision on cost and employment issues. He said he wanted to have this conversation, but he wanted to have the information in front of him prior to making the decision. Mr. Wright further pointed out that this election was a relatively small election with the voters having many options to vote. Chairman Hicks disagreed saying there have been discussions about Sunday voting and extending hours for years and that this was not a hasty decision. He concluded that this was another opportunity where the issue goes into how does "it serve us personally rather than the constituents." He said drive needs to be serving the constituents. Chairman Hicks stated that while opening on Saturday may conflict with other events going on in the county there should be other options to consider. He concluded that there needs to be a time when everyone involved in elections from the local level to the federal government will come together to make it easier for people to vote while protecting the integrity of the vote. Mr. Wright agreed that the discussion needs to be had, but the facts are needed before a decision can be made. Chairman Hicks replied that there needs to be change.

O.C.G.A. 21-2-228(d) and 21-2-231 provide instructions pertaining to the removal of registered voters from an Electors List.

The Secretary of State's Office provides monthly reports to county offices detailing registered felons. This request is based the information provided from the Secretary of State's Office. Families are notified by an official letter informing them of the removal of these electors.

Each person in question has been notified of this meeting via first-class mail as required by law.

WORDING FOR THE AGENDA

Consideration of staff's recommendation to adopt the Fayette County Board of Elections By-laws. This item was tabled at the August 29, 2017 Board of Elections meeting and at the September 26, 2017 Board of Elections meeting.

BACKGROUND / HISTORY / DETAILS

The current by-laws of the Fayette County Board of Elections and Voter Registration was adopted on January 22, 2008.

Amended by-laws were discussed periodically during the first half of calendar year 2016, however, the minutes do not reflect that the amended by-laws were ever adopted.

This item was discussed and tabled at the August 29, 2017 Board of Elections meeting. Revisions to the proposed by-laws were made and the county's current Ethics Ordiance attached for reference.

SPECIFIC ACTION / DIRECTION SOUGHT

Adoption of the Fayette County Board of Elections By-laws.

BYLAWS

FAYETTE COUNTY BOARD OF ELECTIONS AND VOTER REGISTRATION

ADOPTED IN SESSION JANUARY 22, 2008

AMENDED JUNE 28, 2016 SEPTEMBER 26, 2017

I. NAME

The name of this Board shall be the Fayette County Board of Elections and Voter Registration, hereinafter referred to as the "Board."

II. PURPOSE

The purpose of this Board is:

1) To protect the integrity of all elections conducted by the Board.

2) To conduct elections in a legal, ethical, and non-partisan manner with an environment of honesty, openness, impartiality, and integrity, keeping in mind the public trust and interest of all voters in Fayette County. The Board or its members should avoid any action which might result in, or create the appearance of, affecting adversely the confidence of the public in the integrity of any election.

III. CONFLICT OF INTEREST

Board-While conducting the duties of their office, board members should not engage in political activity such as campaigning for any candidate on a Fayette County ballot (whether as a volunteer or a paid position) or ballot question, writing letters to the editor, or participating in discussion or comments regarding candidates or candidates' activities. Board members should conduct themselves in an objective, detached and non-partisan manner while conducting the business of the Board. Board members may not speak at public meetings in support of or in opposition to an issue or candidate on a Fayette County ballot. The Code of Ethics for the Fayette County Government in effect as of the adoption and/or readoption of these Bylaws, as found in Division 3 of Article IV of Chapter 2 of the Fayette County Code of Ordinances and as attached hereto, governs the affairs and activities of the Board and is incorporated by reference into these Bylaws.

IV. ORGANIZATION OF THE BOARD

The Board is empowered to organize itself, determine its procedural rules and regulations, adopt bylaws, specify functions and duties of its employees, and otherwise take such actions as are appropriate to the management of the affairs committed to its supervision; provided, however, that no such action shall conflict with state law. The Chairman of the Board shall be the Chief Executive Officer and shall generally supervise, direct, and control the administration of the affairs of the Board pursuant to law and duly adopted resolutions of the Board as prescribed by law. The Chairman will be elected among the Board members at the February meeting of each even numbered year to serve for a term of two years.

The Board shall enter into its minutes any directives governing the execution of matters within its jurisdiction. The Board shall hold regular monthly meetings at the Elections Office, unless cancelled for lack of business. Any special called meetings shall be held in accordance with the provisions of state law. The Board shall maintain a written record of policy decisions that shall be amended to include additions or deletions. Meetings shall be conducted, insofar as practicable, in accordance with Robert's Rules of Order and Minutes shall be kept of all meetings and shall reflect the votes of each member upon matters voted upon. The Board shall keep correct and complete books and records of account and shall also store the Minutes of all meetings at the Elections Office. Individual Board members may not issue directives to administrative staff or poll workers. All directives to staff and poll workers must be at the behest of the Chairman of the Board and/or the entire Board, acting in its official capacity.

The Board shall be authorized to appoint an Elections Superintendent and to employ any other employees deemed appropriate to manage the matters of the elections and voter registration.

The Board shall be responsible for the selection, appointment and training of poll workers in elections.

V. INVESTIGATIONS

The Board may conduct investigations of irregularities in voting practices, voter registrations, and suspected violations of election laws. Any such investigation shall be conducted in strict compliance with Georgia law and the results shall be made available to the proper law enforcement agencies.

VI. CONFLICT WITH STATE ELECTIONS BOARD RULES

These Bylaws should not be in conflict with the rules of the State Election Board. In case of a conflict, the rules of the State Election Board shall control.

VII. PENALTIES FOR VIOLATION OF BYLAWS

In its discretion, if the Board determines that there has been a violation of these Bylaws, it may impose penalties for said violations(s), including censure and revocation of monthly pay for the Board member. Additional penalties can be imposed by the Board at its discretion.

VIII. AMENDMENTS TO BYLAWS

These Bylaws may be amended by majority vote of the Board at any meeting of the Board, provided that seven (7) days' notice of the intention to amend said Bylaws has been received by Board members, said notice setting forth in detail the proposed amendment. Any

amendment to these Bylaws shall be effective upon adoption, unless otherwise provided for in the amendment.

Sec. 2-200. - Purpose.

The purpose of this code of ethics is to:

- (1) Encourage high ethical standards in conduct by the county officials ("county officials");
- (2) Establish guidelines for ethical standards of conduct for all county officials by setting forth those acts or actions that are incompatible with the best interests of Fayette County (the "county");
- (3) Maintain public trust through transparency by requiring disclosure by county officials of private financial or other interests in matters affecting the county or in matters that affect their ability to act in the best interests of the county; and
- (4) Serve as a basis for disciplining those who do not comply with its terms.

(Ord. No. 2016-04, § 1, 2-25-2016)

Sec. 2-201. - Scope.

The provisions of this code of ethics shall be applicable to all county officials. Further, the county purchasing director shall develop procedures for individuals, corporations and other entities seeking to do business with the county to disclose financial, familial or other relationships with any person who comes within the scope of this code of ethics and who is also required to disclose such relationships. Such disclosures must be made prior to presenting a recommendation of award to the Fayette County Board of Commissioners (the "board of commissioners") or, if board of commissioners approval is not required, prior to execution of a contract in excess of \$10,000. The obligation for an individual, corporation or other entity seeking to do business with the county to disclose the aforementioned relationships is ongoing and shall be enforced as a prerequisite to any action by a county official or other person covered by this code of ethics to renew, extend or otherwise modify a contract after award.

Sec. 2-202. - Definitions.

The following words and phrases as used in this code of ethics shall, unless the context clearly indicates otherwise, have the meanings as follows:

County means Fayette County, Georgia.

County administrator means the individual who serves as county administrator of Fayette County.

County official includes county employees, members of the board of commissioners, the county administrator, the county clerk and the county attorney. County official also includes all individuals appointed by the county administrator and the board of commissioners to county authorities, commissions, committees, boards, task forces, or other bodies.

Gift means the transfer of anything of economic value, regardless of form, without adequate and lawful consideration. "Gift" also means a subscription, membership, loan, forgiveness of debt, advance or deposit of money or anything of value, conveyed or transferred.

Ethics. The discipline dealing with what is good and bad and with moral duty and obligation — Merriam Webster

Immediate family means the spouse, mother, father, grandparent, brother, sister, son or daughter of any county official related by blood, adoption or marriage. The relationship by marriage shall include in-laws.

Person means an individual, a business entity, or other similar type organization.

Sec. 2-203. - Prohibitions.

- (a) No county official shall use or secure confidential information for any purpose other than his/her official duties.
- (b) No county official may participate or vote on any matter before the board of commissioners or other county body where such county official has a substantial interest in the outcome of such matter. For purposes of this code of ethics, a substantial interest is found where the county official receives a pecuniary interest due to the outcome of the vote.
- (c) No county official shall act as an agent or attorney for another in any matter before the board of commissioners or other county body.
- (d) No county official shall enter into any contract with the county except as authorized by state law.
- (e) No county official shall solicit or accept other employment to be performed, or compensation to be received, while still a county official if the employment or compensation could reasonably be expected to impair such county official's judgment or performance of county duties.
- (f) No county official shall disseminate confidential information to someone other than another county official, unless otherwise authorized by law.
- (g) No county official shall solicit or accept gifts, loans, gratuities, discounts, favors, hospitality, or services from any person for himself/herself, or any member of his/her immediate family, under circumstances from which it could reasonably be inferred that a major purpose of the donor is to influence the performance of the county official's duties.

Sec. 2-204. - Conflict of interest.

- (a) No county official may participate in a vote or decision on a matter affecting an immediate family member or any person, entity, or property in which the county official has a substantial interest.
- (b) A county official who has a relationship with any entity which receives funding from the county shall disclose such relationship prior to participating in any action for such funding.
- (c) A county official shall never discriminate by the dispensing of special favors or privileges to anyone, whether or not for remuneration.

- (d) No county official shall engage in any business with the county, or allow any member of his/her immediate family to engage in any business with the county which is inconsistent with the conscientious performance of his/her governmental duties.
- (e) Notwithstanding anything contained herein to the contrary, a county official shall disclose, prior to discussing or taking any action on any matter involving the donor, any gift or campaign contribution (cash or in kind) received by him/her, or any member of his/her immediate family, greater than \$100.00. Receipt of gifts and campaign contributions within the current election cycle valued at \$250.00 or more by a county official, or member of his/her immediate family, will prohibit the county official from participating or taking action on any matter involving the donor.

Sec. 2-205. - Enforcement and administration.

- (a) All allegations of violations of the code of ethics must be filed with the county clerk, in writing, signed by the complainant, no later than 45 days after the alleged act occurred unless the complainant, by exercising reasonable diligence, failed to discover the alleged violation of the code of ethics within such 45-day period. In such case, a complainant must file an ethics complaint with the county clerk no later than 45 days after the complainant discovered the alleged violation.
- (b) In no event shall an ethics complaint be filed with the county clerk more than six months from the date of the alleged violation of the code of ethics.
- (c) The complainant may withdraw the ethics complaint at any time in writing.
- (d) Within 30 days of receipt of an ethics complaint the board of commissioners will review the ethics complaint to determine whether same is on its face unjustified, frivolous, patently unfounded or fails to state facts sufficient to invoke disciplinary jurisdiction. A majority of the full board of commissioners must agree that a sufficient basis has been given to warrant a public hearing. Certain violations alleged against county officials who are employees may be referred through the proper channels consistent with the employee handbook's disciplinary procedures. A majority of the full board of commissioners shall make the determination of whether or not a review board should be impaneled.
- (e) If a complaint is received by the clerk which alleges a violation of the code of ethics by a member of the board of commissioners, a determination of sufficiency of the complaint will not be forwarded to the board of commissioners. The county attorney of any county within the Griffin Judicial Circuit, or any circuit abutting the Griffin Judicial Circuit, other than the county attorney for the county, shall make the determination of whether or not a review board should be impaneled.
- (f) If a review board is needed, three county attorneys, other than the county attorney for Fayette County, within reasonably close geographic proximity of the county will be requested to conduct a public hearing based upon the complaint. A majority vote based upon clear and convincing evidence will determine the existence of the violation or lack thereof. Should the review board find a violation has occurred, the review board will assess the commensurate penalty for the violation. A written decision shall be issued within 15 days of the conclusion of the public hearing. County officials are subject to the following penalties and action for violations of the code of ethics:
 - (1) Written reprimand or public censure;
 - (2) Recovery of value transferred from or received by the county;
 - (3) Cancellation of the contract or rejection of the bid or offer;
 - (4) A monetary fine not to exceed \$1,000.00; and
 - (5) Demotion or termination.
- (g) Any county official adversely affected by any final decision of the board of ethics may appeal as provided in this subsection.

(h) An appeal by certiorari may be commenced in the superior court of the county within 30 days after the decision becomes final.
