#### NEW BUSINESS:

#### 3. Certify the election results of the December 5, 2017 General (Municipal) Runoff Election for the City of Peachtree City.

Director Jones reported that two provisional ballots had been cast during the December 5, 2017 Runoff Election. He reported that the County Registrar, Leigh Combs, recommended approval of both provisional ballots and he gave reason for the approval of the provisional ballots.

Mr. Lester moved to certify the December 5, 2017 Runoff Election with the inclusion of both provisional ballots as approved. Chairman Hicks seconded the motion. The motion passed 2-0-1 with Mr. Wright being absent.

#### **DIRECTOR'S REPORT:**

<u>Weapons</u>: Director Jones stated that at the November 13, 2017 Board of Elections Meeting, he was directed to discuss weapons at the current meeting. He stated that discussion about security should not be on a public agenda. He reiterated that there was county policy prohibiting employees from carrying firearms as well as state law preventing weapons from being within 150' of a polling location. He recommended that the policy be followed and that the proper way to challenge the policy was to take it to the County Commissioners. Chairman Hicks replied that he did not want to change the policy. The Board did not provide further direction on this matter.

Accomplishments: Director Jones provided the Board members with a list of accomplishments that were made in the year 2017. He noted that one accomplishment was that, when he first came to the Elections Office he was met with a request from the Board of Education to move all polling locations out of the schools. He reported that on November 13, 2017, the Board of Education unanimously voted to work with the Board of Elections for the utilization of schools as polling locations. He stated that was a big accomplishment in moving toward the future consolidation of precincts. The Board members agreed with that assessment and made some tweaks to the list. A copy of the list of accomplishments, identified as "Attachment 2," follows these minutes and is made an official part hereof.

Vacation: Director Jones reported that he had approximately two weeks of use-or-lose vacation time to take before the year ended. He asked the Board's blessing to take vacation from Monday, December 18, 2017 through January 1, 2018. Chairman Hicks asked who would be in charge of the office during this time. Mr. Jones replied that County Registrar Leigh Combs would be in charge since during his absence. He further informed the Board that he had authorized Elections Supervisor April Crosby to be out of the office for the same time frame. The Board agreed to Mr. Jones' request.

### WORDING FOR THE AGENDA

Consideration of staff's recommendation to approve a Memorandum of Agreement between the Georgia Soil and Water Conservation Commission and the Election Superintendent of Fayette County, and authorization for the Elections Director to sign said agreement.

### BACKGROUND / HISTORY / DETAILS

The Georgia Soil and Water Conservation Commission has provided a Memorandum of Agreement to Fayette County pertaining to the 2018 General Election.

The agreement (see attached) provides responsibilities to be met by both parties.

The Georgia Soil and Water Conservation District Supervisor position, currently occupied by Mr. Travis Hardy, is a nonpartisan office and will only appear on the November 6, 2018 General Election ballot.

## **SPECIFIC ACTION / DIRECTION SOUGHT**

Approve staff's recommendation to approve a Memorandum of Agreement between the Georgia Soil and Water Conservation Commission and the Election Superintendent of Fayette County, and authorization for the Elections Director to sign said agreement.

#### FOR THE 2018 GENERAL ELECTION

#### MEMORANDUM OF AGREEMENT BETWEEN THE GEORGIA SOIL AND WATER CONSERVATION COMMISSION AND THE ELECTION SUPERINTENDENT OF COUNTY

THIS AGREEMENT, entered into as of this \_\_\_\_\_ day of \_\_\_\_\_, 2018, by and between the **Georgia Soil and Water Conservation Commission**, hereinafter referred to as the "Commission", and the **Election Superintendent of** \_\_\_\_\_\_County, Georgia, hereinafter referred to as the "Superintendent".

WHEREAS, the Commission, pursuant to O.C.G.A. §§ 2-6-23, 2-6-27, 2-6-29, 2-6-30, and 2-6-31, and also pursuant to its Rule 600-9, has powers and responsibilities regarding the election of Soil and Water Conservation District Supervisors; and

WHEREAS, the Code of Georgia further provides, "Successors to elected supervisors shall be elected *at the general election* ..." O.C.G.A. § 2-6-31(b)(1), and

WHEREAS, the Georgia Election Code provides for election Superintendents with powers and responsibilities in the conduct of elections, O.C.G.A. § 21-2-70 *et al.* 

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein, it is agreed as follows:

- 1. The Election Superintendent will conduct and superintend the election of District Supervisors at the general election and in any runoff required by law, as far as is practicable in the manner of any other nonpartisan election in accordance with Title 21 of the Georgia Election Code.
- 2. The Commission will be responsible for placing and paying for legal advertising in a newspaper or other publication of general circulation within the appropriate area.
- 3. The Commission will furnish Nominating Petitions to candidates, and will also provide copies of Nominating Petitions to be placed in the office of the Election Superintendent.

- 4. Candidates will submit completed Nominating Petitions to the Election Superintendent before the deadline of the general election qualifying period. The Superintendent will examine the Nominating Petitions and request the assistance of the Registrar for this and other purposes where the separate function is provided for by law. If difficulties arise the Superintendent will immediately notify the Commission.
- 5. The Superintendent or the Registrar will certify that the Nominating Petitions are subscribed by at least twenty-five (25) qualified electors of that county, and that each nominee is a qualified elector of that county. The Superintendent will then notify the Commission, as soon as practicable, of the results of the certification process by means of the Nominating Petition Review Forms, attached hereto Exhibit "A".
- 6. In elections to fill two positions in one-county Soil & Water Conservation Districts, the two (2) candidates receiving the most votes will be declared the winners.
- 7. In elections to fill three positions in two-county Soil & Water Conservation Districts, the three (3) candidates receiving the most votes will be declared the winners.
- 8. In all cases of ties, runoff elections will be held four (4) weeks following the election for the tied candidates only, and only when the number of candidates tied is greater than the number of available positions.
- 9. Absentee balloting shall be permitted in all district supervisor elections in accordance with Title 21 of the Georgia Election Code.
- 10. Ballots shall contain the names of candidates, listed alphabetically by their surnames, and the incumbent, if applicable, shall be identified.
- 11. Write-in candidates shall be permitted in all district supervisor elections in accordance with Title 21 of the Georgia Election Code.
- 12. The Superintendent shall certify the election results as soon as practicable following the election in the manner for other offices and will complete and return to the Commission the official Election Report form, attached hereto as Exhibit B.
- 13. The Superintendent will "inspect systematically" the conduct of the elections as provided by O.C.G.A. § 21-2-70(8), handling such problems and grievances

as is ordinary for the election, but formal contests and disputes will be handled as provided by law.

- 14. The parties are independent contractors performing public functions provided by law, and each will act according to its own responsibility. For the Commission the exclusive remedy for its torts will be the Georgia Tort Claims Act., O.C.G.A. §§ 50-21-20 et seq.
- 15. The term of this Agreement will be for the conduct of the 2018 general election including any runoff.
- 16. This Agreement is intended to establish a protocol for the conduct of the election of District Supervisors, subject to and in accord with relevant law and rules. It is the entire Agreement and instruction for its purpose outside such law and rules, and therefore any changes in the Agreement must be in writing and agreed to by both parties.

IN WITNESS WHEREOF, the Commission and the Superintendent have executed this Agreement as of the date shown below.
