July 23, 2019 5:00 p.m.

Welcome to the meeting of your Fayette County Board of Elections. Your participation is appreciated. All regularly scheduled Board meetings are open to the public and are generally held on the 4th Tuesday of each month at 5:00 p.m.

Chairman to Call the Meeting to Order

Chairman Lester called the July 23, 2019 Board of Elections Meeting to Order at 5:00 p.m. All Board Members were present.

Approval of the Agenda

Mr. Hicks moved to approve the Agenda. Mr. Wright seconded the motion. The motion passed 3-0.

PUBLIC COMMENTS:

No one spoke during Public Comments.

APPROVAL OF MINUTES:

1. Consideration of staff's request to approve the June 25, 2019 Board of Elections' Meeting Minutes.

Mr. Hicks moved to approve the June 25, 2019 Board of Elections Minutes. Chairman Lester seconded the motion. The motion passed 2-0-1 with Mr. Wright abstaining from the vote.

PUBLIC HEARING:

2. Public Hearing of staff's recommendation to remove registered Fayette County voters from the Electors List who are registered in the State of Georgia's Secretary of State Voter Registration System as deceased.

No one spoke under Public Hearing.

Mr. Wright moved to approve staff's recommendation to remove registered Fayette County voters from the Electors List who are registered in the State of Georgia's Secretary of State Voter Registration System as deceased. Mr. Hicks seconded the motion. The motion passed 3-0. A copy of the request, identified as "Attachment 1," follows these minutes and is made an official part hereof.

CONSENT AGENDA:

There were no Consent Agenda items.

OLD BUSINESS:

There were no Old Business Items.

NEW BUSINESS:

3. Discussion concerning the September 3, 2019 Special Called Election.

Director Jones provided the Board with information on the September 3, 2019 Special Called Election. He stated this election would only involve two precincts and about half of those voters in those two precincts would be eligible to vote. He summarized that there are approximately 90,000 voters in Fayette but this election pertains to only 4,000 voters. He suggested there would be confused voters not understanding why they are unable to vote. He stated that the packet provide to the Board would be placed on the Elections website and it will show the voters how to determine if they live in District 71. Mr. Jones explained why a vote was necessary. He stated that this election has candidates who qualified by party, but this is not a primary election- meaning every candidate's name will be on the ballot. He stated that a winner has to have 50% plus one vote to win without a runoff. He explained that there are three Republican candidates and one Democratic candidate qualified for the Special Election, thus increasing the chance of a runoff election. Mr. Jones stated that two Absentee Polling Places would be opened and he specified those locations would be at the Fayette Election's Office and at the Peachtree City Library. Mr. Jones informed the Board that there would be no early opening of ballots. He notified the Board that Mr. Wright had been appointed by the Republican Party to observe the opening of Absentee by Mail Ballots, and he stated he has spoken to Ms. Fludd of the Fayette County Democratic Committee for an observer to be appointed. He informed the Board that only the Kedron Precinct and Fielding Ridge Precincts would be opened on September 3, 2019. He stated that the AIP sites would be kept open from 8 a.m. to 5 p.m. for the first two weeks of early voting, but that the third week would maintain hours of 7a.m. until 5 p.m. He added there would be a mandatory Saturday vote. He stated that the September 3, 2019 Special Election would cost the county just over \$19,000. He stated that if a runoff is required, then the total cost to the county would be just over \$31,000.

The Board did not take action or provide direction on this matter. A copy of the request, identified as "Attachment 2," follows these minutes and is made an official part hereof.

4. Consideration of staff's recommendation to approve Poll Managers, Assistant Poll Managers, and Clerks for the September 3, 2019 Special Called Election and the October 1, 2019 Special Called Runoff Election, as necessary.

Director Jones stated that the provided list had been confirmed by April. He reported that April is now on vacation, and that about two hours ago a poll manager came to the office stating there is a possibility a clerk needs to be replaced. He asked for the Board to approve the list of poll workers with the caveat that staff could replace the clerk if needed.

Mr. Wright moved to approve the Poll Managers, Assistant Poll Managers, and Clerks for the September 3, 2019 Special Called Election and the October 1, 2019 Special Called Runoff Election with the caveat requested by the Director. Mr. Hicks seconded the motion. The motion passed 3-0. A copy of the request, identified as "Attachment 3," follows these minutes and is made an official part hereof.

5. Consideration of staff's recommendation to revise the Calendar Year 2019 Board of Elections' Meeting Schedule for the Board to certify the September 3, 2019 Special Called Election and subsequent elections.

Director Jones reminded the Board that when it passed the 2019 Special Called Election in November, he told them the Meeting Schedule could be revised. He said the Special Called Election required a change to the meeting schedule by adding September 6 as Certification for the September 3 Election, by adding October 4 for the potential certification of a runoff election, and Friday,

November 8 for certifying the municipal elections. He stated the revised schedule would also cancel the October 22 meeting since that meeting would occur during early voting for the municipalities.

Mr. Hicks moved to approve the amended Meeting Schedule for the year. Mr. Wright seconded the motion. The motion passed 3-0. A copy of the request, identified as "Attachment 4," follows these minutes and is made an official part hereof.

6. Discussion concerning the November 5, 2019 Municipal Elections.

Director Jones presented information about the upcoming municipal elections and he said the information would be placed on the website. He said the intention of the information was to allow interested citizens learn how to qualify for municipal positions. He reminded the Board that qualifying for office will occur in August so the actual candidates are unknown until the next meeting.

The Board did not take action or provide direction on this matter. A copy of the request, identified as "Attachment 4" follows these minutes and is made an official part hereof.

DIRECTOR'S REPORT:

<u>Update on Early Voting Locations:</u> Director Jones reminded the Board that he and Chairman Lester met with Fayette School in May to learn if there was any school property that could be used as a substitute for the Fayette County Elections Office. This effort was initiated after a he and Chairman Lester had a meeting with two County Commissioners, County Administrator Steve Rapson, and the county attorneys. He stated that so far the school had not been forthcoming with information, probably indicating there is no location. Mr. Jones reported that further review of the law was made a few weeks ago and that the opinion from the county attorney was that early voting would have to be conducted at the Fayette County Administrative Complex irrespective of whether additional sites were utilized at schools or the county library. To use the school or county library would, effectually, be opening a fourth early polling location. He stated that unless the Board directed otherwise, he did not see the need to further pursue the school in this matter since it would not yield the desired result. Chairman Lester stated that matter became clear to him at the last meeting with the need to open the Peachtree City location. The Board agreed that the matter of finding alternative locations not be pursued any further.

<u>Southside Church:</u> Director Jones reported that Southside Church had decided to not be used as a polling location even though a deal was almost in place. He explained that the church declined due to the number of Election days throughout the year. He said that continues to leave Evergreen Church as the polling location for two precincts. He said a search is still ongoing to find a polling location for Precinct #33. He said a contact in Peachtree City mentioned she could talk to the leadership of Peachtree City United Methodist Church to see if they would be interested in hosting elections once again for Precinct #33. Mr. Wright added that the Apostolic Christian Church of Peachtree City was directly across the street from the Methodist church and could be a potential polling location. Mr. Jones replied he would look into it.

<u>Crossing a Milestone:</u> Director Jones stated that in a way is seems Fayette Elections has crossed a milestone. He explained that April has been getting compliments from polling locations- the latest being Peachtree City Library- for scheduling elections well in advance. He said this was a practice that apparently was not done prior to his coming to the Elections Office., but that he changed the old practice, and it is bearing favorable results from the polling locations. He further added that Gwinnett County Elections reached out to County Registrar Brian Hill about Fayette's practices. He explained this was a testimony to Brian and to the county since it seems in times past counties would tend to avoid asking Fayette about best practices. That Fayette is being asked is an indicator that respect for its operation is returning.

Upon receipt of ... the lists of persons convicted of felonies in federal courts received pursuant to 52 U.S.C. Section 20507(g), the Secretary of State shall transmit the names of such persons whose names appear on the lists of electors to the appropriate county board of registrars who shall mail a notice to the last known address of each such person by first-class mail, stating that the board of registrars has received information that such person has been convicted of a felony and will be removed from the list of electors 30 days after the date of the notice unless such person requests a hearing before the board of registrars on such removal.

Please be aware that the enclosed information may contain personally identifiable information regarding the particular voter(s) that should be handled and protected appropriately.







Georgia Voting System Frequently Asked Questions: Meet Democracy Suite (D-Suite)

Q: Why is the State of Georgia replacing its current voting system?

The Georgia State Legislature approved the purchase of a new, statewide voting system in order to replace aging, paperless election equipment dating back to 2002. The new system offers Peach State voters more modern, up-to-date technology with important security and transparency features. The new system will also produce a paper ballot to allow for verification and auditing of election results.

Q: How does the new voting system work?

The Dominion Voting Democracy Suite ("D-Suite") system features a ballot-marking device (BMD) that allows voters to verify their choices made on a touchscreen tablet, before printing a paper ballot and placing it into an optical scanner for counting. The paper ballots are used for verifying and auditing results. The next-generation system also offers enhanced audit capabilities for security, as well as features to improve the voter experience.

Q: What is the plan for installing the new system for use in Georgia elections?

The state is taking a phased-in approach, with a county pilot program for the November 2019 municipal election cycle. Statewide system replacement will be completed for the March 24, 2020 Presidential Preference Primary.

Q: How much does the new system cost, and what does the purchase include?

The system cost is approximately \$90 million. The contract includes voting system hardware, software, implementation, training and support for the new statewide system.

Q: How did the state choose the system?

Georgia's Secure, Accessible, and Fair Elections (SAFE) Commission presented a report to the state legislature in January 2019, which used the expert recommendations to adopt a new law for the state's voting system purchase. The procurement process was overseen by the Georgia Department of Administrative Services and handled the same way as other competitive bids. An evaluation committee scored each applicant based on an appraisal of cost and ability to meet the state's voting system specifications, which included accuracy, security, auditability, and ease of use for poll managers and voters. Dominion Voting Systems had the highest overall score and was awarded the contract.

Q: Why is this the best system for Georgia?

Ballot marking devices (BMDs) offer reliability and assurance, balancing the need for both security and accessibility in the voting process. BMDs have proven to reduce the rate of undervotes, overvotes and stray-marked votes in elections. They can specifically alert voters if they have skipped or missed a ballot selection, ensuring that all voting choices are complete. The system also provides full accessibility for people with disabilities and/or language or literacy challenges, allowing all voters to privately and independently cast a ballot using the same system. BMDs also produce paper ballots for auditing and reduce paper volumes overall.

Q: Where can I learn more about the system?

The Secretary of State's office will begin by conducting public demonstrations around the state, with additional county voter outreach opportunities in the fall. A full schedule will be

available on the Georgia Secretary of State's website as soon as possible: https://sos.ga.gov/.

Q: What are the general system components?

Democracy Suite ("D-Suite") includes:

- ImageCastX Ballot Marking Device (ICX/BMD): A universal voting device with accessible options, the ICX BMD operates with a printer that produces a paper ballot.
- ImageCast Precinct Polling Place Scanner (ICP/PPS): Allows ballots to be scanned, capturing ballot images for auditing/review.

Q: How is the new system secured?

The D-Suite system will enable Georgia to defend against cyber threats and deliver reliable election results which can be audited using paper ballots.

- Like the existing voting machines, the new machines do not connect to the Internet, which limits cybersecurity risks. They also create an auditable paper ballot, with other enhanced review capabilities for the public.
- Dominion's product security protocols meet or exceed federal U.S. Election Assistance Commission Voluntary Voting System Requirements (VVSGs).

 D-Suite has significant upgrades to help protect against cyber threats, including use of encryption, multi-factor authentication and role-based access controls.

Q: What if I'm concerned about computerprinted ballots with bar codes?

Most tabulation systems that count paper ballots currently use a barcode to accurately and efficiently count each vote. The Dominion BMD also produces a human-readable ballot summary for voter verification. Plus, election officials test and affirm the security of the system prior to every election, as well as during post-election audits. While voters can be confident in the ability of the BMD system to ensure trustworthy and accurate election results, Dominion will be working with the Secretary of State's office to address perceived concerns regarding use of marked ballots that feature barcodes. For example, the state can make scanned images of all ballots cast in statewide elections available, allowing anyone to do a ballot count to check the accuracy of results.

Earlier this week, the Association's leadership and its Working Group appointed to assist with writing rules and procedure for the new voting system met with Michael Barnes and Chris Harvey in Atlanta to learn more about our new voting system and to ask questions. The State folks did a great job answering our question to the extent that information was available. We hope within the next couple of weeks to have more information to share, but for now, here is what we found out:

- There are multiple components to the system:
 - o The voting unit is called a ballot marking device and consists of a tablet on a stand that is connected to a desktop printer, which together is the voting unit.
 - o There will be an external universal power supply for each voting unit, which will serve as the battery back up for the printers.
 - o At each polling site, there will be a scanner/tabulator that will sit atop a large molded plastic ballot box into which the voter will place their paper ballot.
 - The ballot box will hold approximately 2,500 voted ballots.
 - It was reported that those of us who have precincts having registered voters greater than the 2,500 ballot capacity will receive enough ballot boxes and scanners to accommodate the number of registered voters at our precincts.
 - The molded plastic ballot box will nest for storage purposes
- It was recommended that the tablet used with the ballot marking device be stored vertically and on its wheels instead of laid flat atop one another. This will be important for you to know as you plan for your storage needs
- If you currently have Balotar, your Balotar will be replaced at no cost to you with Dominion's Mobile Ballot Printing module and a new printer. These will be replaced one per one, so no county will have less capability than had with the old system. The Mobile Ballot Printing set up does not include a folder like many of our Balotars currently have.

•	Soon, the Secretary of State's Office will launch an information portal called Dynamo that will be very
	similar to Firefly, but for the sole purpose of information sharing regarding the new voting system.
