Chairman Hicks called the Board of Elections meeting to order at 5:00 p.m.

Mr. Lester moved to approve the Agenda and to add an additional public comment after the presentation of New Business #2 in order to give audience members the ability to the matter. Mr. Wright seconded the motion. The motion passed 3-0

## **NEW BUSINESS:**

Mr. Hicks considers Mr. Peter Pfeifer's Notice of Challenge to Eligibility to Vote

Mr. Stough said this particular challenge is being brought as you mentioned O.C.G.A 21-2-230. Which basically allows any elector to challenge the ability of another elector in the county to vote in an upcoming election. Once such a challenge has been received by the

Election Board. The Election Board is to determine whether there was probable cause exist sustain the challenge. If the Election Board determines there was probable cause then we are to notify the poll officers and let them know that any one that comes in to vote that was on that list is going to have to go before the Election Board to determine their residency before they can vote. If the Election Board determines that there isn't probable cause, then the challenge is denied. The challenge appears to be based on that there is two sets of voters that the challenge is under discussion. The first appears to be 51 people listed in a spreadsheet that was attached to the challenge. The letter is claiming that these people moved or registered to vote in Fayette County after the November 3, 2020 Election. The other set of voters were 4 people that were listed on a second spreadsheet, I'm not really sure what was the allegations were. It appears to be that these people may have voted in another Senate Election in another State in November and they've since registered to vote here. I don't know what the bases of that, there is no, it doesn't say what the grounds for believing that is. There is nothing the letter that explain that.

Mr. Wright says I don't think giving credit to any of these. I think the idea was if you are registered in a particular State, let's say and that State had a Senate Election which is statewide and you voted in that State then there contending that they should not now be able to be allowed to vote in our State Senate or our States Senate Election.

Mr. Stough says I think that's probably what is being alleged here. They site to a particular federal law that says that you can't vote in the same election for Senator in a given election, you cannot vote twice in a given election for Senator.

Mr. Wright answers for two different States?

Mr. Stough says well it doesn't say that. It says that you cannot vote twice in the same election for Senator. Each State that had Senate elections this last year was having a separate election that wasn't one single election.

Mr Wright answers Sure.

Mr. Stough says so I don't know if that was an accurate reading of the law. As far as the other list of voters., the 51 who apparently registered to vote since November, it appears that their allegations is that these people may have moved here just for the purpose of voting in this election. But other than a list of quotes from Twitter of people suggesting that people do that, there is really no allegations to support that.

Chairman Hicks ask is there anymore comments?

Mr. Lester asked do you have the second Attachment.

Mr. Stough answers "It was the spreadsheet had two tabs. It was a bit hard to tell. The first tab had the 51 and then the second tab hade the 4.

Mr. Wright asked Agnes Bridges did you look at these particular voters to see if there is anything that was out of the ordinary.

Ms. Bridges answers No, when I looked at the findings I have not received anything stating to be removed off of the registry. Which by law I cannot remove anyone without their consent. So I didn't find anything out of the ordinary for them.

Mr. Wright asked did you check to see if they were registered in multiple States at the same time or anything like that.

Ms Bridges answers I did not because we would have to check with each State to see if they were registered there. I did not.

Mr. Stough and just of be clear if someone is registered to vote in one State and moves to Georgia to register to vote here. Usually there is nothing for the voter to do to end their registration in another State. We are supposed, we through the SOS office is supposed to notify the other States.

Mr. Wright asked have we notified the other States that these people are registered in Fayette County but no longer need to be registered in those other States.

Ms. Bridges answers I have not mentioned that to anyone at the SOS. I am not aware that we have to call the other States. The SOS does that.

Mr Stough says that I don't think that is for the county to do. The SOS handles that.

Mr. Lester moved to deny the requested challenge of Peter Pfeifer's request. Mr. Wright seconded the motion. The motion passed 3-0
