Director Hill answered the question from Ms. Brenda Cox about Credit "It was an issue at the early voting location and it was a data entry error on the Fayette County Elections office. The poll worker issued two voter certificates to the dad and the son in which the son was supposed to read over the pre filled out voter certificate printed out by the Easy Vote application and if everything looked good, he was supposed to sign it two times. But the son failed to look at the error and signed it as his dad's information. We train our poll workers to ask the voter if everything looks good then sign the voter certificate. He voted but it wasn't for his name, but it was for his dad so the son did not receive credit for voting because he had his dad's voter certificate. The dad did receive credit.

Chairman Hicks asked "So that basically is the voter came in and requested a ballot, received the wrong voter certificate and signed but didn't read it. Chairman Hicks referenced an example saying "If I came in and voted as Darryl Hicks and the voter certificate read as John Hicks and I signed it, that means I am taking someone else's vote.

Director Hill answered Chairman Hicks "That is Correct Sir"

Chairman Hicks asked Brenda Cox did she have any other questions concerning this matter.

Brenda Cox answered "No that answered my question"
