Deputy County Registrar Review of Provisional Ballots:

1. Review and consideration of Provisional Ballots cast for December 6th, 2022, General Election Runoff & December 6th, 2022, Peachtree City Special Election Runoff.

Deputy Registrar Ms. Ramessar: Good evening, I will be reviewing the results of the Peachtree City municipal runoff election followed by the General runoff election.

For Peachtree City Municipal runoff:

There are 12 accepted Provisionals.

There are 10 rejected Provisionals which break down as follows:

1 rejected because the voter was not registered

2 rejected because not within city limit

7 rejected after registration cutoff

Which brings the total to 22 provisional ballots for the Peachtree City municipal runoff.

For the General Election runoff:

There are 23 accepted Provisionals.

There are 19 rejected Provisionals which break down as follows:

14 rejected because voter registered in wrong county

1 voted in wrong precinct before 5:00pm

4 were not registered at all

Which brings the total to 42 provisional ballots for the General Election runoff.

I am an AIP Manager and also a Election Day Manager. I really enjoy working for Elections. I am requesting that Election Day poll workers get a pay increase. Thanks

Brad Sanders, Fayette County

Hello. Just wanted to thank elections. All the workers, and everyone who was involved with this election, clean, smooth, well organized well run. And I just want to say thank you.

Brenda Wicker, Fayette County

I work as a poll worker for AIP and on election day. I know you'll probably get a lot of pressure to continue having seven to seven hours. We know it is a lot of stress. The more days that we've worked in the seven to seven. The more tired you get, the more likely you are to have mistaken. It's at least 14-hour days the last day is closer to 17-hour day. While we did have good turnout. All those days, I really didn't see a lot of new people accessible for more people. It just seemed like the same people we see. In 17 days, we saw in five I don't know how big of a change that was. I know there was a lot of pressure to have it. extended hours for people to be able to get there before after work, but it seems like people can get to doctors and banks and other things during nine to five and can work that out. Sounds even like voting had to be different. If we do have to add more hours maybe just an hour on the end would be a possibility, or having more people on the teams, so that we can have days.

Walt Hamlin, Fayette County

I'd like to second what the poll worker said that seven to seven and inquire why we're limited to just for early voting, especially on the compressed November runoffs they can open additional advanced voting for those occasions it may be avoid having to do some of the sevens. And now we provide another opportunity for more people because the lines here were horrendous. I mean, I drove by here a number of times, they'd be backed up all the way down the hallway here and at the library to be all the way across the front of the library. So, I know a lot of people avoided voting early in that case. So, if you could possibly open additional voting facilities are senators. That would be great. Thank you.
