Suzanne Brown, Peachtree City: (1) Asking on behalf of all Municipal residents that Fayette County precinct polling place and Municipal Precinct polling location are the same and that polling location be inside their Municipal boundary. (2) Redistricting 36 precincts down to 19 precincts may cause issues to develop. (3) Trust issues with Dominion machines. Why are the same machines being used to produce the same style ballots? Suggesting going back to sequentially numbered security paper ballots that are hand counted. (4) Transparency in the process. Post redistricting map proposal on website for all citizens to see.
