### **BOARD MEMBERS REPORTS:**

Mr. Hicks (question for the attorney): What does the state law say about signatures?

Dennis Davenport (attorney) response: Bound to provide records that are responsive unless they're exempt from disclosure, either under the Open Records Act itself or under another law. Either in federal or state law. There are particular exemptions that apply to elections records. Don't believe signature cards are covered. Don't think there's anything that would exempt signature cards from disclosure.

Mr. Rower (question for the attorney): Is there anything about privacy in the state constitution about signatures?

Dennis Davenport (attorney) response: Don't believe there is anything broad enough to cover something like a signature card. When the Open Records Act has to be strictly construed. If it is not specifically spelled out in the Open Records Act, there's nothing we can do as far as exempting those records.

Mr. Rower: We will follow the law to the best of our ability and if we cannot respond with signatures, then we will not respond. Will take every legal action that we possibly can.
