Not enough parking spaces. Additional parking should be provided off Johnson Ave. Not enough security at 7 pm on election day. Staff should check in with polling managers at 6:30 to see if extra security is needed.

William Jennings III: Fayette County since 1996. Voter fraud speech.

Brenda Wicker: Poll Manager in Fayette County for seven years. Requesting cell service in Tyrone to be boosted. Issues with cell service during elections. Request county to invest in more poll pads with printers.
