CHAIRMAN TO CALL THE MEETING TO ORDER

Chairman Wright called the Election Board Meeting to order at 7:58 PM. Due to an unusual circumstance in our county, a massive power outage delayed the start of the meeting by three hours. Vice Chairman Rower motioned to amend the agenda and move new business to the top of the agenda to consider provisional ballots cast for December 5, 2023, municipal runoff election.

APPROVAL OF THE AGENDA

Chairman Wright motioned to amend the agenda to put new business in front of public comments. Motion approved 3-0. Remainder of agenda approved 3-0.
