- The GARVIS report, which includes unique voter numbers, can be compared to the Election Summary report. The Election Summary report reflects the most recent tabulation results.
- A precinct failed to scan their emergency ballots. To address this, the office convened a Vote Review Panel to scan the emergency ballots into the Election Management System (EMS).

• A batch of absentee ballots was received at the office at 2:30 P.M. and is currently under review for eligibility and adjudication.

Board Member Alexander inquired about the ballots from Fayetteville East.

Director Garrett clarified that when poll officials emptied their scanners, they separated the ballots into two sealed bags. All ballots from Fayetteville East were scanned and tabulated.

Director Garrett also noted that one absentee ballot received on Election Day was not scanned on Election Night. That ballot, along with any UOCAVA ballots, was scanned during the Vote Review Panel's session.
