## A. Review of Precinct Returns

Director Garrett reviewed the contents of the meeting materials, which included the Advance Voting Report, Election Summary Report, Statement of Votes Cast, and a list of precincts with a column labeled "regular" showing Election Day check-ins.

Vice-Chair Alexander inquired whether the report tools could automatically total counts for each precinct and voting method to confirm consistency with the overall totals. Director Garrett explained that the Elections Management System (EMS) is not connected to the Internet. Results come from EMS and are transferred via USB drive to the Director on Election Night for upload into the system. This allows the Director to generate reports from multiple systems and compare them to the EMS server results.

Vice-Chair Alexander asks if the Election Summary Report could include the precinct number in the future in which Director Garrett explains that the precinct numbers could only be included if manually adjusted.

Vice-Chair Alexander asks if the number of registered voters for a precinct is updated through the date of the election.

Director Garrett confirmed that voter registration has a cutoff date for each election. She added that the only changes after that point occur if a voter cancels their registration or if the Secretary of State sends delayed registration information that must be processed.

Vice-Chair Alexander inquired on whether the totals reflect registered voters or active voters. Director Garrett confirmed the numbers reflect only active voters.
