

Per the referenced flood insurance rate map, a portion of this lot is in a Zone A (no base flood elevation determined) flood hazard area and a portion is in a Zone "X" unshaded designated area. However, per the Subdivision Plat the required minimum finished floor elevation is 872.0. Per the attached Flood Hazard Certificate, the base flood elevation is 869.0. This house and lowest adjacent grade to the house is above and out of the 100 year flood plain. W. D. Gray and Associates, Inc. did not participate in establishing the Base Flood Elevation. The machinery in section "C" (C2e) is an outside HVAC unit. Sq. Ft. in section "A" are approximate. The Latitude and Longitude was determined using google earth.
