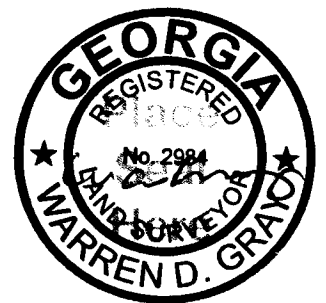

However, per the attached Flood Hazard Certificate (see attached) issued by the Fayette County Environmental Management that states that the Base Flood Elevation at this lot is 849.18 with a required minimum finished floor elevation of 853.0, this house and lowest adjacent grade to the house is above and out of the 100 year flood plain.
