

Per the referenced flood insurance rate map, a portion of this lot is in a Zone A (no base flood elevation determined) flood hazard area and a portion is in a Zone "X" unshaded designated area. However, per the attached Flood Hazard Certificate (see attached) issued by the Fayette County Environmental Management Dept., the Base Flood Elevation at this lot is 849.18 with a required minimum finished floor elevation of 852.18, this house and lowest adjacent grade to the house is above and out of the 100 year flood plain. W. D. Gray and Associates, Inc. did not participate in establishing the Base Flood Elevation. The machinery in section "C" (C2e) is an outside HVAC unit. Sq. Ft. in section "A" are approximate. 
