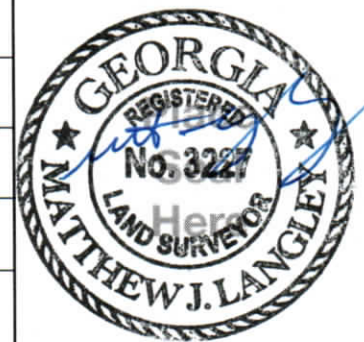

According to the above referenced FIRM, by graphic scaling, a portion of this LOT is graphically shown to be in Zone AE. However, according to the elevations in Section C, this house and the lowest adjacent grade to the house lie entirely in Zone X unshaded and is outside and above the base flood elevation. The latitude and longitude were taken from Google Earth. The machinery elevation in section C2e represents the basement floor elevation (there appears to be a furnace and hot water heater). The square footage should be considered approximate. It should be noted that larger floods can and will occur, flood heights may be increased by man-made (pipe failures, cart paths, etc.) or natural causes.
