Emergency Management Agency

Fayette County Emergency Management Agency is responsible for coordination, planning, and liaison activities with municipal, state, federal, private sector, and non-governmental organizations to maintain Fayette County's ability to mitigate, prepare, respond, and recover from disasters while maintaining our eligibility for disaster assistance and reimbursement at the maximum level allowed.

In 2023, Fayette County was awarded a hazard mitigation grant in the amount of \$3,879,505. These funds allow our community to restore damaged infrastructure due to natural disasters while also supporting the efforts of Fayette County to better prepare for future emergencies. This award is part of FEMA's Hazard Mitigation Grant Program which provides funds to state agencies and local governments. It will fund the Longview Dam (Margaret Phillips Lake Dam) and Kozisek Dam located within Fayette County. The project consists of performing the necessary evaluation, design, permitting, and construction to bring the structures into compliance with the Georgia Safe Dams Act of 1978, and eliminate the flooding hazards of the

properties downstream of these dams.

Other notable activities and accomplishments for 2023 include:

- Eligibility for an incentive program directed by the State of Georgia that qualifies Fayette County for reduced cost share for FEMA-approved disaster expenses
- Coordinated with American Red Cross to evaluate shelter locations within Fayette County
- Assisted the Fayette County Board of Education with the development and review of school safety plans
- Participation in three Fayette County disaster exercises
- Coordinated Hazard Mitigation grant applications
- Coordinated testing and maintenance of the outdoor warning siren system
- Assisted fire victims by performing liaison functions with the American Red Cross
- Assisted the Training Division with NPQ check-offs for fire recruits and National Registry practical skills for EMT and Paramedic testing

Fire/EMS Training

In 2023, the department completed two fire recruit classes with a total of 22 personnel. Each class was 480 hours long and included both mental and physical challenges. Upon completion, these men and women successfully completed the National Professional Qualifications Firefighter Level I and II testing process, as well as Hazardous Materials Awareness and Operations levels.

The training division also completed two combined Emergency Medical Technician (EMT) and Advanced Emergency Medical Technician (AEMT) classes. Each combined class was 760 hours long. Upon completion, these men and women successfully passed the National Registry AEMT cognitive and psychomotor exams to become Georgia state licensed AEMT's.





The training division, along with adjunct instructors from partnering agencies and line personnel, provided multiple continuing education courses. These courses expand the knowledge and skill set of personnel to ensure we provide the highest level of care and services to the citizens of Fayette County.


The classes provided in 2023 were: Fire Officer I, Fire Instructor I, Advanced Medical Life Support, Pre-Hospital Trauma Life Support, Emergency Pediatric Care, Pediatric Advanced Life Support and Advanced Cardiovascular Life Support.

The training division and line personnel also provided mutual aid training with Clayton County Fire & Emergency Services, Fayetteville Fire Department and Peachtree City Fire Department to ensure familiarity with equipment and personnel to facilitate the rapid deployment of resources in the event of a large or complex incident.

In addition to the training provided by the department, many personnel attended courses at the Georgia Public Safety Training Center, Metro Atlanta Firefighters Conference, Fire Department Instructors Conference, as well as the Georgia Fire Service







Bureau Of Fire Prevention



The Bureau of Fire Prevention is the first line of defense against loss of life and property due to fires in Fayette County. Our goals are achieved through annual fire and life safety inspections, fire investigations, quality public safety education programs, fire alarm and sprinkler acceptance testing, life safety plan reviews on new construction and remodels, and periodic inspections as required or requested by business owners. Along with serving all of unincorporated Fayette County, we also provide fire prevention services to the towns of Tyrone, Brooks, and Woolsey. We work closely with the leadership in each of these communities to provide a firesafe environment for their residents and visitors.

We provide public safety education to many citizens throughout the year, from preschool-age to seniors. These programs include our 3rd Grade fire safety education at all the elementary schools in unincorporated Fayette County, safety education at the Fayette Senior Center, events at local churches and other organizations, and fire extinguisher training for citizens and businesses within Fayette County.





The Bureau of Fire Prevention staff are trained as fire inspectors, fire investigators, life safety plans examiners, and public safety educators. The division's members each attend over 100 hours of continuing education per year in the areas of fire investigation, fire operations, inspections, fire code review and compliance, and community risk reduction. With the addition of our new drone, we can now conduct aerial reviews of fire scenes and high hazard commercial properties. This will also assist our inspectors when conducting site visits for new construction and subdivisions.

National Opioid Settlement Funds

Fayette County Fire and Emergency Services received approximately \$30,000 from the National Opioid Settlement Agreements. We were able to purchase and distribute over 560 Naloxone kits to other departments in the county, our partnering agencies, and two different nonprofit organizations (In Ryan's Name, Drug Free Fayette). The partnership with In Ryan's Name led to the installation of the first Naloxone dispensing box in Fayette County.
