JOB SUMMARY

This position is responsible for participating in the installation, maintenance and repair of the water distribution system and reservoir infrastructure, locating underground water lines, providing service to customers in the field, participating in meter reading operations and inspection of water infrastructure. This position will respond to afterhours emergencies on a rotating schedule.

Based on expertise and/or evaluation of management staff, the employee will be assigned one of the primary assignments listed below within Field Operations but will be expected to participate in all areas of operations based on department needs.

MAJOR DUTIES

Infrastructure Maintenance Operations

- Incumbent serves as a senior member of infrastructure maintenance operations.
- Insures work is completed according to approved standards and guidelines.
- Tests backflow prevention assemblies as certified; installs, repairs, or replaces assemblies.
- Experienced and skilled in the methods of repairing leaking, damaged water mains and services.
- Experienced and skilled in the methods to installs water taps, services, and water meters.
- Installs, repairs, inspects and flushes fire hydrants.
- Repairs concrete driveways or sidewalks along with sod removal and repairs.
- Operates a variety of mechanical and heavy equipment; cement mixer, gas powered saw, asphalt and cement cutter, trenching/boring machine, jackhammer, asphalt roller, backhoe etc.
- Hand delivers boil water advisories and rescind notices; collects bacteria samples as needed.
- Repairs and maintains water reservoir infrastructure.
- Maintains inventory of tools, parts, and equipment.

Customer Response Operations

- Incumbent serves as a senior member of customer response operations.
- Insures work is completed according to approved standards and guidelines.
- Experienced and skilled in the methods to read water meters manually and using AMR/AMI equipment.
- Experienced and skilled in the methods to repairs and maintains water meters.
- Experienced and skilled in the methods to assist customers with water service concerns.
- Turns water services on and off as appropriate.
- Locks meters off on delinquent accounts.
- Flushes and performs inspections of fire hydrants.
- Maintains inventory of tools, parts, and equipment.

Damage Prevention Operations

- Incumbent serves as a senior member of utility locate operations.
- Insures work is completed according to approved standards and guidelines.
- Reviews and codes UPC locate requests.
- Experienced and skilled in the methods to Identify, locate and mark distribution system infrastructure using electronic locating equipment.
- Experienced and skilled in the methods to locate, maintain accessibility and ensure operation of all distribution system
- Meets with contractors on the job site as needed.
- Investigates damages to distribution system infrastructure.
- Record distribution system infrastructure on digital maps.
- Maintains inventory of tools, parts, and equipment.

Field Inspection Operations

- Incumbent serves as a senior member of field inspection operations.
- Insures work is completed according to approved standards and guidelines.
- Ensures compliance with the Water System's Developmental Standards.
- Reviews construction plans.
- Experienced and skilled in the methods to inspect new and existing water main and service construction.
- Meets with contractors and developers throughout the construction process.
- Coordinates planned interruptions of water service for construction projects.
- Inspects reservoirs, dams and other related structures.
- Maintains dams; prepares dams for annual state inspections; repairs pipes; cut trees and underbrush; checks gates, locks and fences, paints of graffiti, picks up garbage.
- Record distribution system infrastructure on digital maps.
- Maintains inventory of tools, parts, and equipment.
- Performs other related duties as assigned.

KNOWLEDGE REQUIRED BY THE POSITION

Infrastructure Maintenance Operations

- 1. Considerable knowledge of water system distribution installation, repair, and maintenance procedures.
- 2. Knowledge state and federal environmental regulations
- 3. Skill in the operation and maintenance of heavy and light equipment.
- 4. Skill in the repair and maintenance of the water distribution system.

Customer Response Operations

- 1. Considerable knowledge of the installation, repair, and maintenance of water meters.
- 2. Knowledge of meter reading processes and equipment.
- 3. Skill in the determination and resolution of water service problems.

Damage Prevention Operations

- 1. Considerable knowledge of as-built water system plans.
- 2. Skill in locating and marking underground water lines.

Field Inspection Operations

- 1. Considerable knowledge of Georgia Department of Transportation guidelines and regulations. ?
- 2. Considerable knowledge of Public Service Commission laws and rules.?
- 3. Skill and reading and interpreting construction and utility plans.

- 1. Considerable knowledge of county policies and procedures.
- 2. Considerable knowledge of water meter, water line and hydrant locations.
- 3. Considerable knowledge of computers and job-related software programs.
- 4. Skill in the operations of an assigned vehicle.
- 5. Skill in public and interpersonal relations.
- 6. Skill in researching information and preparing reports.
- 7. Skill in planning and meeting deadlines.
- 8. Ability to communicate verbally and in writing. Ability to understand, follow and transmit instructions.

SUPERVISORY CONTROLS

The Foreman assigns work in terms of general instructions. The supervisor spot-checks completed work for compliance with procedures, accuracy, and the nature and propriety of the final results.

GUIDELINES

Guidelines include OSHA guidelines, traffic control procedures, and county and department policies and procedures. These guidelines are generally clear and specific but may require some interpretation in application.

COMPLEXITY/SCOPE OF WORK

- The work consists of related maintenance duties, meeting with customers, cutting water on and off as needed, meter reading and repairs, computer reading equipment, locating underground utilities and field inspections. Inclement weather conditions, heavy traffic and the variety of residents and situations encountered contribute to the complexity of the position.
- The purpose of this position is to participate in repair and maintenance of the water distribution infrastructure, provide field service to customers, and participate in meter reading operations, locating underground utilities and inspection of water system infrastructure. Success in this position contributes to the efficiency of Water System operations.

CONTACTS

- Contacts are typically with co-workers, customers, developers, builders, contractors, and members of the general public.
- Contacts are typically to give or exchange information, resolve problems and provide services.

PHYSICAL DEMANDS/ WORK ENVIRONMENT

- The work is performed while intermittently sitting, standing, stooping, bending, or crouching. The employee frequently lifts light and heavy objects, climbs ladders, and uses tools or equipment requiring a high degree of dexterity.
- The work is typically performed outdoors and occasionally in cold or inclement weather. The employee may be exposed to noise, dust, dirt, grease, and machinery with moving parts. The work requires protective devices such as the use of masks, goggles, and gloves.

SUPERVISORY AND MANAGEMENT RESPONSIBILITY

This position may provide temporary supervision over Field Operations Technician III and II.
