Also needed is power (generators) for the inflatables, sound, etc...

Drone Policy:

Kenwood Park Monument and Memorial Garden:

New Business:

Grants: Pete Nelms will begin to assist in obtaining grants for the county. A current project includes a grant for hand-held lightning detection devices. Possible future projects include a trail grant and a soccer grant. Let Anita Godbee know if you hear of any grants worth pursuing.

Exercise Stations:

Installation of new exercise stations to be installed at McCurry Park. They will be clustered to resemble an outdoor gym and be a nice upgrade to our park. We will be seeking sponsors for each station.

Staff Reports: Commissioners agreed at the recent Board of Commission Retreat to increase outdoor pavilion rental rates per our recommendations to \$30 for county residents and \$60 for out of county residents. These rates will go into effect on September 1, 2016.

A consensus at the retreat was not made regarding Out of County Park Access. Discussions were held regarding doing things fairly and the possible involvement of pay stations at the parks. The board will continue to discuss.

A report was made about security issues at the parks. Kiwanis and Kenwood currently have entrance cameras. A meeting was held at McCurry Park to discuss better security and cameras.

Anita Godbee invited commissioners to McCurry Park this weekend for disc golf, football, and soccer tournaments, etc...

Revised by-laws were passed out.
