Fayette County, Georgia is seeking to procure the services of a qualified, professional Radio Frequency (RF) consulting firm to conduct a needs assessment, and provide procurement support, implementation support, and other project management services for an upgraded public safety radio system. You are invited to submit a proposal in accordance with the specifications and information contained herein. All required information should be included with your proposal.

Please note: Award of this contract is dependent upon passage of a Special Local Option Sales Tax (SPLOST) in Fayette County on March 21, 2017.

A Pre-proposal Conference will be held at 10:00a.m., Thursday, February 16, 2017 at Fayette County 911 Communications Center, 110 Volunteer Way in Fayetteville, GA 30214. This will be the opportunity to view the site, voice all questions, concerns and comments about this Request for Proposals, and have them addressed.

All questions and inquiries concerning this request for proposals or the specifications shall be addressed in writing no later than 3:00pm, Thursday, February 23, 2017, Attention to: Trina Barwicks, Contract Administrator of Purchasing, email to: tbarwicks@fayettecountyga.gov or fax to (770) 719-5515, Monday through Friday excluding holidays from 8:00am to 5:00pm. The telephone number is (770) 305-5420. Any deviations from this procedure for questions or information pertaining to this request for proposal may result in your proposal being rejected.

All prices shall be F.O.B. Destination, Fayette County. Be sure to include the <u>proposal</u> <u>number</u> and <u>reference</u> along with your company's name and address on the <u>sealed</u> envelope in which the proposal is returned.

TERMS AND CONDITIONS REQUEST FOR PROPOSALS #1229-P: RADIO COMMUNICATIONS SYSTEM CONSULTANT

- 1. **Definitions:** The term "contractor" as used herein and elsewhere in these Terms and Conditions shall be used synonymously with the terms "consultant" or "successful offeror." The term "county" shall mean Fayette County, Georgia.
- 2. **Preparation of Offers:** It shall be the responsibility of the offeror to examine specifications, scope of work, schedule and all instructions that are part of this request for proposal. Failure to observe any of the instructions or conditions in this request for proposal may result in rejection of the offer.

All of the specifications and information contained in this request for proposal, unless specifically excepted in writing by the offeror and such exceptions being included with the offer, will form the basis of the contract between the successful offeror and the county. The offeror should take care to answer all questions and provide all requested information.

- 3. **Submission of Offers:** Offerors must submit their proposal, along with any addenda issued by the county, in a sealed opaque envelope with the following information written on the outside of the envelope:
 - a. The offeror's company name,
 - b. The Request For Proposals (RFP) number, which is 1229-P, and
 - c. The "reference" which is Radio Communications System Consultant

Mail or deliver one (1) <u>unbound</u> original proposal (paperclip or binder clip acceptable, no staples), signed in ink by a company official authorized to make a legal and binding offer, two (2) paper copies, and a copy on a flash drive to:

- 4. **Timely Receipt**: Offers not received by the time and date of the scheduled proposal opening will not be considered, unless the delay is a result of action or inaction of the county.
- 5. **Open Offer:** The offer, once submitted and opened, shall remain open for acceptance for a period of at least ninety days from the date of the opening unless this time-frame is specifically excepted to in your offer.
- 6. Corrections or Withdrawals: The offeror may correct a mistake, or withdraw a proposal before the proposal opening date by sending written notification to the Director of Purchasing. Proposals may be withdrawn after the opening only with written authorization from the Director of Purchasing.

The county reserves the right to waive any defect or irregularity in any proposal received.

In case of discrepancy between the unit price and the extended or total price, the unit price shall prevail.

- 7. **Trade Secrets Confidentiality:** If any person or entity submits a bid or proposal that contains trade secrets, an affidavit shall be included with the bid or proposal. The affidavit shall declare the specific included information which constitutes trade secrets. Any trade secrets must be either (1) placed in a separate envelope, clearly identified and marked as such, or (2) at a minimum, marked in the affidavit or an attached document explaining exactly where such information is, and otherwise marked, highlighted, or made plainly visible. See Georgia law at O.C.G.A. § 50-18-72 (A)(34).
- 8. **Site Conditions**: Offerors are urged to visit the site to familiarize themselves with site conditions. Upon submission of an offer, it is understood that the offeror is acknowledging his acceptance of all site conditions.
- 9. **References**: Offerors shall submit with proposals a list of three (3) jobs the offeror has done that are of the same or similar nature to the work described herein. For each job listed include a brief description of the work, a contact person, mailing address, valid telephone number and the date job was completed.
- 10. Ethics Disclosure of Relationships: Before a proposed contract in excess of \$10,000.00 is recommended for award to the Board of Commissioners or the County Administrator, or before the County renews, extends, or otherwise modifies a contract after it has been awarded, the contractor must disclose certain relationships with any County Commissioner or County Official, or their spouse, mother, father, grandparent, brother, sister, son or daughter related by blood, adoption, or marriage (including in-laws). A relationship that must be reported exists if any of these individuals is a director, officer, partner, or employee, or has a substantial financial interest the business, as described in Fayette County Ordinance Chapter 2, Article IV, Division 3 (Code of Ethics).

If such relationship exists between your company and any individual mentioned above, relevant information must be presented in the form of a written letter to the Director of Purchasing. You must include the letter with any bid, proposal, or price quote you submit to the Purchasing Department.

In the event that a contractor fails to comply with this requirement, the County will take action as appropriate to the situation, which may include actions up to and including rejection of the bid or offer, cancellation of the contract in question, or debarment or suspension from award of a County contract for a period of up to three years.

- 11. Evaluation of Offers: The evaluation of offers and the determination as to acceptability of services offered shall be the responsibility of the county. Accordingly, to insure that sufficient information is available, the offeror may be required to submit literature, samples, or other information prior to award. The county reserves the right to obtain clarification or additional information from any firm regarding its proposal. The county reserves the right to select a responsive, responsible firm on the basis of best value that is deemed to be most advantageous to the owners. The county further reserves the right to reject any proposal, or all proposals, and to re-release the request for proposals.
- 12. **Non-Collusion:** By responding to this request for proposals, the offeror shall be deemed to have represented and warranted that the proposal is not made in connection with any other offeror submitting a separate response to this request for proposals, and is in all respects fair and without collusion or fraud.
- 13. **Ability To Perform:** The offeror may be required, upon request, to provide to the satisfaction of the county that he/she has the skill, experience and the necessary facilities, as well as sufficient financial and human resources, to perform the contract in a satisfactory manner and within the required time. If the available evidence is not satisfactory to the county, the county may reject the offer.

- 14. **Notice to Proceed**: The County shall not be liable for payment of any work done or any costs incurred by any offeror prior to the county issuing a written notice to proceed.
- 15. **Unavailability of Funds**: This contract will terminate immediately and absolutely at such time as appropriated and otherwise unobligated funds are no longer available to satisfy the obligations of the county under the contract.
- 16. **Severability**: The invalidity of one or more of the phrases, sentences, clauses or sections contained in the contract shall not affect the validity of the remaining portion of the contract. If any provision of the contract is held to be unenforceable, then both parties shall be relieved of all obligations arising under such provision to the extent that the provision is unenforceable. In such case, the contract shall be deemed amended to the extent necessary to make it enforceable while preserving its intent.
- 17. **Patent Indemnity:** The contractor guarantees to save the county, its agents, officers, or employees harmless from liability of any kind for use of any copyrighted or uncopyrighted composition, secret process, patented or unpatented invention, articles or appliances furnished or used in the performance of the contract, for which the contractor is not the patentee, assignee or licensee.
- 18. **Indemnification**: The contractor shall defend, indemnify and save the county and all its officers, agents and employees harmless from all suits, actions, or other claims of any character, name and description brought for or on account of any injuries or damages received or sustained by any person, persons, or property on account of any negligent act or fault of the successful offeror, or of any agent, employee, subcontractor or supplier in the execution of, or performance under, any contract which may result from proposal award. The contractor shall pay any judgment with cost which may be obtained against the county growing out of such injury or damages.
- 19. **Non-Assignment**: Assignment of any contract resulting from this request for proposal will not be authorized.
- 20. **Insurance**: The contractor shall procure and maintain the following insurance, to be in effect throughout the term of the contract, in at least the amounts and limits set forth as follows:
 - **General Liability Insurance**: \$1,000,000 combined single limit per occurrence, including bodily and personal injury, destruction of property, and contractual liability.
 - **Automobile Liability Insurance**: \$1,000,000 combined single limit each occurrence, including bodily injury and property damage liability.
 - Worker's Compensation: Workers Compensation as required by Georgia statute.
 - Professional Liability (Errors and Omissions) Insurance: \$2,000,000 limit per claim and aggregate.

Before a contract is executed with the successful offeror, the successful offeror shall provide Certificates of Insurance for all required coverage. The successful offeror can provide the Certificate of Insurance after award of the contract, but must be provided prior to execution of the contract document by both parties. Certificates shall list an additional insured as follows:

- 21. **Termination for Cause**: The county may terminate the contract for cause by sending written notice to the contractor of the contractor's default in the performance of any term of this agreement. Termination shall be without prejudice to any of the county's rights or remedies by law.
- 22. **Termination for Convenience**: The county may terminate the contract for its convenience at any time with 10 days' written notice to the contractor. In the event of termination for convenience, the county will pay the contractor for services performed. The county will compensate partially completed performance based upon a signed statement of completion submitted by the contractor, which shall itemize each element of performance completed.
- 23. **Force Majeure**: Neither party shall be deemed to be in breach of the contract to the extent that performance of its obligations is delayed, restricted, or prevented by reason of any act of God, natural disaster, act of government, or any other act or condition beyond the reasonable control of the party in question.
- 24. **Governing Law**: This agreement shall be governed in accordance with the laws of the State of Georgia. The parties agree to submit to the jurisdiction in Georgia, and further agree that any cause of action arising under this agreement shall be required to be brought in the appropriate venue in Fayette County, Georgia.

OBJECTIVE

Fayette County, Georgia seeks to procure the services of a qualified, professional Radio Frequency (RF) consulting firm to conduct a needs assessment, and provide procurement support, implementation support, and other project management services for an upgraded public safety radio system.

Please note: Award of this contract is dependent upon passage of a Special Local Option Sales Tax (SPLOST) in Fayette County on March 21, 2017.

INTRODUCTION

Fayette County, Georgia operates a Public Safety radio system which is housed at the 911 Communications Center, and provides services to the Cities of Fayetteville, Peachtree City, the Town of Tyrone; Fayette County Board of Education; Fayette County Sheriff's Office, Fayette County Marshal's Office; and Fire & Emergency Medical Services. The current system is a Motorola Astro 4.1 trunked simulcast system, with seven radio tower sites.

STATEMENT OF NEED

The current system is at end-of-life and will need replacement to comply with Federal Communications Commission rules and regulations for narrow banding, and Project25 compliance with digital voice format. Interoperable communication with jurisdictions outside the community is an essential component. The county seeks a qualified consulting firm that can assist with all aspects of the replacement project, including needs assessment, procurement support, implementation support, and other project support as may be appropriate. To assure independent conclusions and recommendations, the chosen consulting firm must not be involved with the sale, installation, or service of recommended equipment or systems, nor be associated with companies that provide these services.

SCOPE OF SERVICES

The scope of services to be provided by the consulting firm includes provision of the following components:

- 1. A complete operational assessment of radio communications requirements.
- 2. Recommendations for upgrading the communications network, including plans and designs.
- 3. Procurement support for any equipment, materials, or services as may be needed.
- 4. Implementation support and project management services.

PROPOSAL RESPONSE REQUIREMENTS

Proposals must include the following, in the order shown:

1. **Cover Page**: Include the Request for Proposals number (#1229-P) and title (*Radio Communications System Consultant*). Also include your firm's name, address, telephone number, fax number, and e-mail address.

2. Table of Contents

- 3. **Required Documents:** Company Information Page, Contractors Affidavit and signed addenda, if any.
- 4. **Understanding and Approach**: State your understanding of the services required. Describe the approach you propose to take in addressing the needs addressed by this request for proposals. Identify major milestones to be achieved in completing the project. Indicate your level of expertise with public safety answering points, computer aided dispatch, records management systems, Next Generation 911 or other Internet protocol-based systems, geographical information systems, and/or other relevant technologies.

Describe your firm's background and size. Include the number of years in business; the corporate structure, legal status and professional credentials. If you would use any subcontractors or partners in delivery of the proposed services, identify them and explain their roles.

- 5. **Project Team**: Identify team members who would be likely to be assigned to projects as listed in the Scope of Services. Include a resume for each key team member. Identify the main contact person for the county. Include copies or other proof of key team members' licenses or certifications which are pertinent to this project. Describe each key team member's experience with comparable projects, the role that each member played, and the expected role of each when doing work for this project. The project team may include personnel hired by the firm directly, or a mixture of personnel and outside sub-consultants.
- 6. **Firm's Expertise and Experience**: Demonstrate the firm's experience and qualifications by listing relevant projects that were similar to the work addressed by this request for proposals. Projects within the last five years are preferred, but projects over five years ago may be considered if relevant.

Describe any specialization or unique capabilities of your firm. This may include technical innovation, cost effectiveness, community outreach, or other capabilities in which you excel.

- 7. **Quality of Written Proposal:** The Evaluation Team will consider such factors as effectiveness of communication, relevance of information provided, overall layout, or other factors as may be appropriate.
- 8. **References**: Supply a list of contracts completed in the last twelve months that were of similar nature, and contact information for each, as specified in the Terms and Conditions, Item #9.

9. **Price Schedule**: Include a price proposal sheet that contains, in a clear format and in detail, the components of your billing structure for the work described in this request for proposals. Show separate proposed prices for the four components of the Scope of Services, as shown above.

EVALUATION PLAN

An Evaluation Committee will review and evaluate proposals. The points earned for technical merit will comprise 70% of your evaluation score. Criteria for technical merit are, in priority order, as follows:

- 1. Understanding and approach
- 2. Project team
- 3. Firm's expertise and experience
- 4. Quality of written proposal

PRICING

The remaining 30% of your score will be determined by your proposed prices, as compared to other responding companies.

The county may at its discretion, choose one or more of the best-scoring companies to make in-person presentations. If more than one company makes a presentation, the Evaluation Committee will evaluate and score the presentations, and adjust evaluation score totals accordingly.

Each proposal shall include an unbound original, two hard copies, and a copy of the document on a flash drive.
