**Subject: Invitation to Bid #1653-B: Pavement Evaluation & Sign Inspection -
Addendum #1**

Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced Invitation to Bid. You will need to consider this information when preparing your bid.

1. **For the sign inventory, what method does the County require for measurement of retro reflectivity?**

The County does not require a set method but the method used must meet MUTCD guidelines. Responders are to list the method bid on the revised pricing sheet included herein.

2. **Is there a stated accuracy requirement for sign location?**

Yes, all sign locations would need to be within 2 feet.

3. **Do you need price totally separate for sign inventory and pavement management? There is a huge cost difference for doing them at the same time versus totally separate. Can we send price for combine effort?**

Please see the revised pricing sheet. The pricing sheet list Option A; itemized pricing and Option B; total project amount not itemized. As listed in the General Terms and Conditions #18, The County reserves the right to make award by evaluation/inspections, or by lump sum award. The award will be made in the best interest of the County.

4. **Would the County entertain the use of a different pavement evaluation and management system?**

No, not for this invitation to bid.

5. **For the sign inspection would the County consider an assessment and management method, as defined in the MUTCD, other than retro-reflectivity readings?**

The County is seeking for retro-reflectivity for this bid. Currently the County does the night time inspections and attempts to replace all signage when a road is resurfaced.

6. **If the County desires retro-reflectivity readings, would the County consider adding a line item on the pricing sheet for a retro-reflectometer?**

The purchase of a retro-reflectometer is not included in this invitation to bid.

7. **The Road Assessment sections states that each roadway is to be broken down into segments beginning and ending at cross streets. Just for clarification, we assume this to mean that at each cross road, being a road that intersects on one side and continues its alignment across roadway in question. Just want to make sure a segment is not one where a road only intersects on one side of the road in question. Please clarify.**

Road segments are broken down by cross streets that includes where one road intersects on one side of the road.

8. **Exceptions to Specifications; we are of the understanding that this page is where we list our exceptions. The form states "Any exception(s) shall be explained in full". We have approx. 4 pages of explanation of exceptions. Can those 4 pages be attached to the submittal?**

If additional sheets are needed for exception(s) or clarification(s); yes, include them in your submitted bid.

9. **Does the county have a count on the total number of signs that are erected throughout the county? We need this total number to be able to evaluate how long it will take to complete the field inventory.**

As per the last inventory there was 6,201 sign posts. We do not have the exact numbers on how many signs are attached to each post.
