Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced invitation to bid. You will need to consider this information when preparing your bid.

1. **Is there really a need for a bid or performance bond since you will not have any financial obligation until units are delivered and paid for? It just adds unnecessary cost to the ambulances.**
Bonds shall be provided as required per specifications.
2. **We do not currently have a dealer in Georgia and will not meet the requirement for service within 75 miles as listed in the proposal. Will this eliminate us from consideration as a bidder?**
This would make the submitted bid non-compliant with specifications.
3. **Please use the attached Company Information page when submitting your bids. It is part of the required documents list. (Attachment #1)**
4. **Do you need power locking compartments?**
Yes, use of the OEM key fob and door locks in the cab should lock/unlock all compartments and module doors.
5. **Do you have a Fleet Purchase Number?**
We are in contact with Ford Motor Company to obtain our number.
6. **Is the red you specified, a standard red or is it a special red?**
The specifications are clear as to the color numbers and paint brand.
7. **How are the numbers affixed to the current ambulances? (Attachment #2)**
Attached in a frame held by spring loaded clips. Final mounting locations at the 100% inspection. Picture provided.
8. **Please provide specifications for lettering style, font and material. Please provide pictures/samples of current ambulance that is lettered to spec. (Attachments #3-#6)**
Gold-black background shadowing / Gold to be Reflective/ 10 Year Warranty / Pictures are attached.
9. **Fayette County wishes to receive pricing for an alternative to the performance load system specified in the Invitation to Bid. Please price the Stryker Power Load Ambulance Cot Loading System as an alternative to the performance load system specified in the invitation to bid. This price should be inclusive of all components associated with the cot and loading system and installation cost. Attached is an updated Pricing Sheet with this alternate loading system listed. (Attachment #7)**



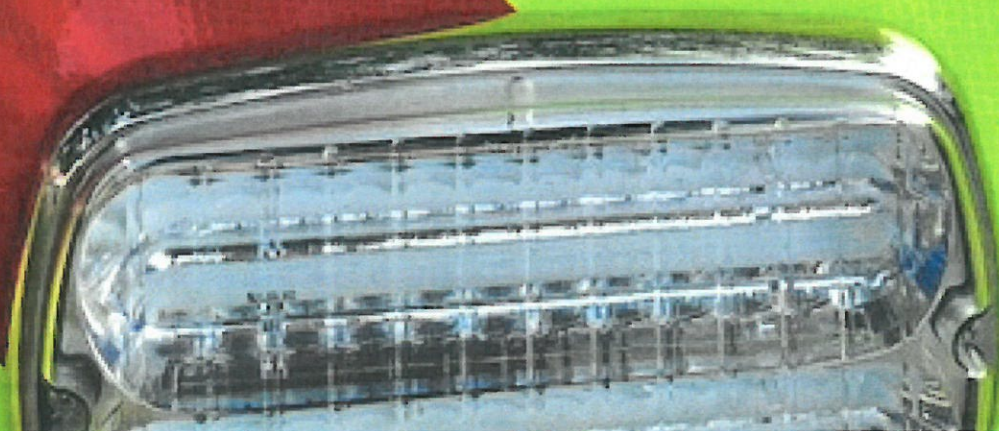
