**Subject: ITB #1744-B: Fuel Management System Upgrade - Addendum #1**

Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced Invitation to Bid. You will need to consider this information when preparing your bid.

**Fleet Location:**

1. **Do you want to replace both Fuelmasters?**  
Yes.
2. **Do you want fiber optics or a wireless system?**  
Wireless system.
3. **Do you want anything in the cloud?**  
No.
4. **Concerning the fiber optic, who is responsible for providing media converters?**  
No longer applicable.
5. **Do you have a fiber optic switch to connect to?**  
No longer applicable.
6. **Where are you going to terminate the fiber optic inside?**  
No longer applicable.
7. **Who will do the work?**  
It will be the responsibility of the successful bidder to perform all necessary work for a turn-key operation.
8. **Why are you going with fiber optic?**  
No longer applicable.
9. **Which hoses are controlled by which head unit?**  
Master unit controls hose #'s 1, 2, 3 & 4. The satellite controls hose #'s 5, 6, 7 & 8.
10. **What head unit is the propane connected too?**  
Satellite unit – propane is on hoses 7 & 8.
11. **Do you want the fiber optic pulled to both head units?**  
No longer applicable.
12. **What are your plans if we cannot use the underground conduit?**  
No longer applicable.
13. **Could we do an alternate price for Wi-Fi options?**  
No longer applicable.

14. **Will Fiber optic have to be done by a low voltage contractor?**  
No longer applicable.
15. **If we run fiber optic through conduit and fiber optic breaks who is responsible for the damaged fiber optic?**  
No longer applicable.
16. **Is the cloud based completely out of possibilities?**  
Cloud based database is not acceptable.
17. **Is Wi-Fi an option for you?**  
Wireless point to point system is acceptable.
18. **What about the option of a redundant antenna?**  
Redundant antenna is not necessary.
19. **Do you want to replace the tank monitor?**  
Yes.
20. **Does the system have to monitor these 2 types of leaks? Both sump leak monitor and interstitial leaks between the walls of the tank?**  
Yes.
21. **Where is the tank monitor being moved to?**  
Based on information provided at pre-bid meeting, the new tank monitor will be installed where the existing tank monitor is located. However, it will be the responsibility of the successful bidder to facilitate connection of this equipment to our network. Connection to the county network shall be coordinated with the Fayette County Information Technology Department. A printer is not necessary.
22. **Where is the closest electrical panel?**  
Electrical panels are located at the rear of the building.
23. **How many fuel tanks do you have?**  
(2) Two
24. **If you go wireless, where will the antenna be mounted?**  
It was understood at the pre-bid meeting that all vendors present were capable of installing a wireless system that would function properly. It will be the responsibility of the successful bidder to install the antenna in an appropriate location to ensure the system functions according to factory specifications.

**Sheriff's office:**

25. **Do you want a SQL data base?**  
The county can provide a SQL database instance if needed to fulfill software requirements.
26. **Where does the database reside now?**  
The current Microsoft Access database resides on a network file share.
27. **Do you want to replace the incon tank monitor?**  
Yes, the specifications called for the tank monitor to be listed as an option. Since there will be a significant savings going with a wireless system, the tank monitor at this location be replaced.
28. **If we put an antenna on the Judicial Center building how far into the building do we have to go to connect to it?**  
Vendors were given an opportunity to access requirements for the antenna connection. It will be the responsibility of the successful bidder to ensure adequate materials are provided to facilitate proper installation of the necessary equipment.

29. **Can we get a boom lift near the building to put up an antenna?**

Vendors were able to access grounds conditions. If they are comfortable with safe maneuvering of a boom lift near the building this method is acceptable.

30. **Is the IDP room on outside wall of the Judicial Center?**

No.

31. **Do you have sets of old plans you can send us?**

If needed, plans will be made available upon award to the vendor performing the work.

32. **Will the network cable to be run on the ceiling of the third floor of the Judicial Center need to be in conduit?**

Conduit is not necessary. However, the network cables must be installed in a neat and workmanlike manner (secured and not drooping).
