**Subject: RFQ #1756-A: Signs for Parks & Lakes - Addendum #1**

Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced request for quote. You will need to consider this information when preparing your quote.

**1. Can you elaborate on EG Digitally Printed?**

On this type film the warranty is not as good. It seems to be more cost effective than 3M. EG Digitally printed is a type of film used during printing. The warranty for EG meets the specifications required in the RFQ but is less than 3M film printed sign. The EG film is also more cost effective than the 3M film.

**2. Are you wanting the sign to be reflective vinyl?**

No.

**3. Will you need mounting holes in the faces to install or will you drill the signs accordingly?**

The county will drill holes accordingly.

**4. Wanting to confirm that you will handle supplying all posts and install, delivery of signs only correct?**

Yes.

**5. Will the back of the sign be mill finish aluminum or does the backs need painted?**

Mill finish is acceptable.

**6. It states that the final design for all 20 locations is to be submitted with the initial quote. Is this correct?**

It has been determined that only 2 designs will need to be submitted with the initial quote. One design should be the Brooks Park sign and the other design should be the Lake Horton Park sign. See the attached samples.

**7. Do you all have a copy of the text for each sign & raster images for all logo's and graphics that you can send to us? We will need these for the design layout.**

Word documents of the Brooks Park and Lake Horton signs are attached. The logo will be emailed to the vendor who is awarded the contract. The graphics used on the signs should be representative of what is displayed on the samples.

**8. Do you have a delivery dock?**

A delivery dock is not available so items should be shipped in a lift truck. A delivery date should be set up in advance so Fayette County can be prepared to receive the items.

**9. Is the Fayette County logo changing?**

No. Fayette County will provide the successful bidder a copy of the Fayette County logo prior to printing.

**10. Does the 4x3 size include the arch?**

No. The arch should be on top of the 4x3 sign.

**11. Are design fees for the samples to be included in our quote?**

Design fees for the samples required during submission of the quotes shall not be included.

**12. Is there a due date for completion?**

Please state on the pricing sheet the length of time needed to complete project once a Notice to Proceed has been issued.



- PERSONS UNDER THE AGE OF 13 MUST WEAR A U.S. COAST GUARD APPROVED PERSONAL FLOTATION DEVICE AT ALL TIMES WHILE ABOARD ANY VESSEL
