Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced Invitation to Bid. You will need to consider this information when preparing your bid.

- 1. Will Fayette County provide the required electrical service (480v, 3 phase, 100 amp) and water service (1.5" line w/ 70psi) at each of the sites designated for the dewatering equipment?**  
Fayette County will provide electrical and water service for the project.
- 2. With this being a dewatering project, it is industry standard to allow bidders to collect representative samples for dewatering analysis to determine cake solids, polymer selections, etc. Please explain why the County will not allow samples to be collected at the pre-bid?**  
Pre-bid attendees MAY take desired samples during the site visits. Sample containers and devices will not be provided by FCWS. Samples can only be taken from the shore.
- 3. You state in addendum #1, answer #9, that this is a "lump sum" price. The pricing page clearly indicates this being a unit price, by the ton, project. Please clarify?**  
The bid will be evaluated on the cost per ton.
- 4. In regards to the unit pricing, is this per "dry ton" or "wet ton"?**  
Unit pricing per wet ton as reflected on required landfill manifests.
- 5. Without being able to take samples to determine percent solids of the sludge do you have any analysis that would help determine how many tons are in the overall volume estimate?**  
S Pre-bid attendees MAY take desired samples during the site visits. Sample containers and devices will not be provided by FCWS. Samples can only be taken from the shore.
- 6. Are companies bidding on this project required to have a 'license' to do business in GA? I did not see this requirement in the bid documents however, some states require this were others do not and I just wanted double check.**  
All vendors must meet GA licensing requirements.


