Another 2,047 were contacted through the web-based Georgia Procurement Registry, who had registered under commodity code #91052 (Maintenance and Repair Services), #91065 (Remodeling and Alteration Services), #91484 (Trade Services, Construction), and #91054 (Painting, Maintenance and Repair Services). The offer was also advertised through Georgia Local Government Access Marketplace and the Fayette County website.

Three (3) Companies submitted quotes. (Attachment 1).
