Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced Invitation to Bid. You will need to consider this information when preparing your bid.

- 1. Should there be a crack seal item in the bid schedule?**
Yes. The Price Sheet (Attachment #1) and Road Specifications (Attachment #2) have been updated.
- 2. Will the contractor need to provide temporary traffic markings before the thermo striping will be put down by the county?**
No. No existing striping will be affected by the resurfacing project. The limits of Lodge Trail begin at the state R/O/W which is at the nose of the concrete median.
- 3. Does the paving include the turn lanes into and out of The Chimney's and Rebecca Estates Subdivisions?**
No. These areas will not be resurfaced under this contract.
- 4. Will portable tripod mounted signs be okay to use rather than post mounted signs?**
Yes. Portable tripod signs will be acceptable for this project.
- 5. Do you want the paving to match the curb and gutter line for all the streets listed?**
Yes. All pavement should match the existing curb & gutter for all roads.
- 6. The Chimney's Subdivision has manholes on every road and cul de sac. There is no spec in the bid package for this and wanted to know if risers would be good for the manholes or if you wanted to handle them in a different way. Will an item in the bid schedule be added if they are needed?**
All roads in the Chimney's Subdivision are full mill. The asphalt shall be placed back at the same current elevation of the manholes.


