Below, please find responses to questions, clarification, or additional information for the above referenced RFQ. You will need to consider this information when preparing your quote.

1. How many current contractors are cleaning the buildings?
Two contractors

2. Do any of these locations need pricing on day porters or is this simply for night cleaning?

No, day porter prices are not needed. Only one price should be submitted for each location. The various hours of cleaning are listed in the specifications.

3. Does each location need its own proposal, or do you want one large proposal for all locations?

The RFQ contains all the necessary documents needed to submit your quote. The Price Sheet has a line for each location.

4. In the meeting last week, I asked about assigning the contract to one or more of my authorized Jani-King Franchisees. The gentleman there said he would get back with us on that. When can I expect an answer if this is permissible; for your RFP states that it would have to be authorized in writing?

Sub-contractors are not allowed.

5. How many employees are required to clean the buildings?

This is decided by the contractor.

6. How many offices and restrooms in each building? Is there a map of each location? Attachments 2 contains maps of each area, with the exception of the Public Defenders office and McIntosh restroom.

7. Is there a closed door policy?

No, all offices are to be cleaned. Please do not clean storage areas and locked offices.

8. Kiwanis Park office: Is there water available downstairs?

No. Water is available upstairs and outside.

9. Kiwanis Park office and Gym: What areas are to be cleaned?

Only areas with tiled flooring, no cement floor areas.

10. Can you please provide the amount of the Last awarded Bid? Attachment 1 is the bid information for the current cleaning contract.


