2. Do you want the numeric 3 painted over the entry?

Yes. Paint shall match the existing color.

3. The original Scope of Work and Specifications is updated to include the following:

Contractor shall include the small outbuilding in the back when pressure washing, cleaning, prepping, and painting.

4. Is there access to water?

Yes.

5. The Contractor shall use a semi-gloss paint. This replaces the flat paint specified in the original Request for Quotes.


