Senior Center

1. **The Senior Center shows four (4) sections on the building, but only two sections have details. Are there any details for section 2 and section 3?**
Section 2 the dome wood needs to be replace all upper and middle sections and any other place found that's bad.
2. **Are there any active interior leaks?**
No
3. **Can a second look be approved for a later day?**
Unfortunately, we will not be able to provide a second visit to the Senior Center.
4. **Will there be any replacements to the shingle roof?**
No
5. **Are there quantities built in or will it be the contractor's discretion on what boards and shingles to replace?**
This will be the contractor's discretion.
6. **Is there an order of repair for the three buildings or sections within the buildings?**
No, however the contractor shall complete each section before moving to the next.
7. **Is the interior work part of the project?**
No. The county will make the necessary repairs inside of the building.
8. **Should the quote include replacing of the metal panel?**
Only metal flashing is to be replace.
9. **Once the wood is redone do you want the flashing tilted when replaced?**
Yes
10. **Please clarify the section of the TPO to replace.**
The raise vent hood area.


