Contract #2237-A: Firefighter Uniforms - Revised

The Purchasing Department issued Request for Quote #2237-A to secure vendors to provide Fire & EMS uniform shirts and pants. Notice of the opportunity was emailed to 26 companies. Another 261 were contacted through the web-based Georgia Procurement Registry, who had registered under commodity code #20085 (Uniforms, Blended Fabric) #20087 (Uniforms, Synthetic Fabric), and #20137 (Emblems, Braids, Buttons, and Patches for Caps and Uniforms, Including Chevrons, Epaulettes and Shoulder Boards). The offer was also advertised through Georgia Local Government Access Marketplace and the Fayette County website.

Six companies submitted quotes (Attachment 1). Fire & EMS recommends awarding to the lowest responder for each uniform item. A Contractor Performance Evaluation for previous work is attached (Attachment 2).
