Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced **RFQ**. You will need to consider this information when preparing your quote.

- 1. Questions regarding this solicitation has been extended until 3:00p.m., Thursday, June 29, 2023.
- 2. The new opening time and date of this RFQ is 3:00p.m., July 5, 2023.
- 3. FDR Composite Samples will these be 6 mix designs that need to be performed, or is this the strength specimens needed to be made during the mixing of the roadways? If these are the production compressive strength specimens, are you needing 6 sets (normally sets of 3) or just 6 specimens? Curious since the FDR Mix Design review was defined as the review of designs created by others.

The contractor per GDOT specification 315 is now responsible for preparing the mix-design which needs to include the cost to take similar samples as the contractor to verify that the existing materials will be satisfactory for the proposed mix design. For FDR Composite Samples we are looking for compressive strength test of the completed FDR project for each location. The testing standard is a set of three-cylinder groups for each location, the contractor shall supply two (2) sets of three-cylinder groups for this project.

- 4. The FDR portion of the RFQ has been reduced to two road, Hampton Road, and Wilmington Way. As a result the quantities on the Price Sheet has been adjusted, Attachment 1.
- 5. Asphalt Cores Will these cores be taken after all the pavement (binder and topping) has been placed or will these be taken after each type of asphalt is placed? 10 cores are listed... Do you know approximately how many trips?

For asphalt cores looking for cores after all the pavement has been placed (binder and topping).
