Contract 2353-A: Water System Parking Lot Striping

The Purchasing Department issued Request for Quotes 2353-A to secure a contractor to stripe three parking lots for the Water System. Notice of the Opportunity was emailed to 20 companies. Another 283 were contacted through the web-based Georgia Procurement Registry, who had registered under commodity code 91276 (Striping: Streets, Parking Facilities, Land Divisions, Paint, etc.) The offer was also advertised through Georgia Local Government Access Marketplace and the County website.

Six companies submitted quotes (Attachment 1). During review of the quotes, the Purchasing Department made multiple requests to the lowest responder for references relevant to striping. The lowest responder, Chucks Auto Sale, LLC, was non-responsive and has been disqualified.

The Water System recommends awarding to the lowest, responsive responder, M. E. Thomas Select Services, LLC. A Contractor Performance Evaluation is not available since this is the first time contracting with M. E. Thomas. The Purchasing Department checked their references, and the results were favorable.
